18 A Grand Jury of the County of Yolo, State of California,
19 hereby accuses by this Indictment, the following defendants of
20 committing, in the County of Yolo, the following crimes:

21 **COUNT 1**

22 **[MORTGAGE FRAUD]**

23 Count 1 : On or about July 1, 2025, TAMMY KIKU MACHADO did
24 commit a FELONY, namely, a violation of Section 532f(a)(1) of
25 the California Penal Code, MORTGAGE FRAUD, in that TAMMY KIKU
26 MACHADO did deliberately make any misstatement,
27 misrepresentation, or omission during the mortgage lending
28 process with the intention that it be relied on by a mortgage

1 lender.

2 **COUNT 2**

3 **[WILLFULLY FALSE RETURN]**

4 Count 2 : On or about June 5, 2025, TAMMY KIKU MACHADO did
5 commit a FELONY, namely, a violation of Section 19705(a)(1) of
6 the California Revenue and Taxation Code, WILLFULLY FALSE
7 RETURN, in that TAMMY KIKU MACHADO did willfully and unlawfully
8 make and subscribe a return, statement, and other document, that
9 contained and was verified by a written declaration that it was
10 made under penalty of perjury, and which they did not believe to
11 be true and correct as to every material part, for the tax year
12 2024.

13 **COUNT 3**

14 **[WILLFULLY FALSE RETURN]**

15 Count 3 : On or about April 14, 2024, TAMMY KIKU MACHADO
16 did commit a FELONY, namely, a violation of Section 19705(a)(1)
17 of the California Revenue and Taxation Code, WILLFULLY FALSE
18 RETURN, in that TAMMY KIKU MACHADO did willfully and unlawfully
19 make and subscribe a return, statement, and other document, that
20 contained and was verified by a written declaration that it was
21 made under penalty of perjury, and which they did not believe to
22 be true and correct as to every material part, for the tax year
23 2023.

24 **COUNT 4**

25 **[CHILD ENDANGERMENT]**

26 Count 4 : On or about July 1, 2025, TAMMY KIKU MACHADO did
27 commit a FELONY, namely, a violation of Section 273a(a) of the
28 California Penal Code, ABUSING OR ENDANGERING HEALTH OF A CHILD,


1 in that TAMMY KIKU MACHADO did willfully and unlawfully, under
2 circumstances and conditions likely to produce great bodily harm
3 and death, did willfully cause and permit said child to be
4 placed in such a situation that the child's person and health
5 was endangered, to wit, authorizing the possession and storage
6 of dangerous fireworks, explosives, destructive devices, and
7 materials to create destructive devices, in the "Yellow Shop,"
8 the "Warehouse," and Storage Containers near the residence of
9 SAMUEL ELMO MACHADO and TAMMY KIKU MACHADO.

10 **COUNT 5**


11 **[ANIMAL CRUELTY]**

12 Count 5 : On or about July 1, 2025, TAMMY KIKU MACHADO did
13 commit a FELONY, namely, a violation of Section 597(a) of the
14 California Penal Code, KILLING, WOUNDING OR TORTURING ANIMALS,
15 in that TAMMY KIKU MACHADO did willfully, unlawfully, and
16 maliciously kill, maim, mutilate, torture, and wound an animal.
