Under and by the virtue of the authority vested in me by Section 105-369 of the North Carolina General Statutes, I am hereby advertising tax liens for the year 2025 upon the real estate described below. The listings are for taxes billed in 2025 which were not paid as of June 1, 2026 and do not include any prior years of unpaid taxes. The amounts advertised will be increased by interest and costs and the omission of interest and costs from the amount advertised will not constitute a waiver of the taxing unit's claim for those items. The real estate that is subject to the lien may be foreclosed by the taxing unit and the property sold to satisfy the taxing unit's claim for the taxes. Taxes are listed in the name of the record owner as of January 1, 2025. These collection procedures do not apply to taxpayers who may be under a current bankruptcy plan."
