AFFIDAVIT

The undersigned upon oath deposes and states as follows: to-wit: that the affiant has been employed with the Enid Police Department in Enid, Oklahoma in Garfield County since October 25th, 2001. That the affiant is currently assigned to the Investigative Service Division, and is assigned to investigate criminal violations of State and Municipal laws.

At 5:55 P.M. on June 25th, 2016 Brian O'Rourke called the Enid Police Department to report a domestic at 1814 West Maine in the City of Enid, County of Garfield, and State of Oklahoma. When Brian reported the domestic he stated that the residence was his daughter's, Jamie O'Rourke. At 5:57 P.M. Christopher Reynaud called 911 and stated that he lived at 1814 West Maine. When Christopher called 911 he stated that he needed police and ambulances. The 911 dispatcher asked Christopher what was going on and he stated that he had some people intruding on his property and stated that he had shot them.

When officers arrived at the residence they located three people outside of the residence, and all three of them had gunshot wounds. Christopher was also located at the residence and came outside and surrendered. All three of the victims at the scene with gunshot wounds were treated by emergency personnel.

An 18 year old male victim by the name of Jonathan Winters was transported to Bass Hospital where he was treated for a gunshot wound to the left side of his head and gunshot wound to his left leg. A 21 year old female victim by the name of Alyssa Cull was transported to Wood Ring Airport where she was Medi-Flighted to OU Medical Center in Oklahoma City, Oklahoma for a gunshot wound to the chest. A 17 year old male victim by the name of Daultn Dickerson was transported to Bass Hospital with a gunshot wound to the chest. Daultn was pronounced dead at 6:55 P.M.

On June 25th, 2016 your affiant and Detective Robin Bench spoke with Christopher Reynaud after he was taken into custody. Christopher was read the Miranda Warning and agreed to speak with your affiant and Detective Bench. Christopher stated that Alyssa, Jonathan and Daultn had all come over to his residence. Christopher said that he did not like any of them and did not want them there. Christopher said that he spoke with his girlfriend Jamie O'Rourke and asked her to make them leave. Christopher was asked if he heard Jamie tell them to leave and he said that he did not. Christopher said that Jamie was unable to get the three of them to leave, so he said that he snapped and shot all of them. Christopher said that Alyssa, Jonathan and Daultn never refused to leave and that none of them ever made any threats of violence towards him.

Christopher said that he was inside of the residence when he grabbed a Smith and Wesson M&P 9mm handgun from his bedroom. Christopher then went outside where all of the victims were located. He said that he raised the gun up and deliberatly shot Daultn in the sternum, then turned and shot Alyssa in the sternum. Christopher said that he jumped over the porch railing and fired two shots at Jonathan. Christopher said that he hit Jonathan in the head and in the leg with the shots that he fired at him. Christopher said that he then yelled that this was "his turf". Christopher then went back in the house and called 911.

Your affiant then spoke with Jonathan Winters at the Enid Police Department. Jonathan stated that he, Daultn and Alyssa went to the residence on Maine to speak with their friend Jamie O'Rourke. Jonathan said when they arrived Christopher was at the residence. Jonathan said that while at the residence Christopher stayed in the bedroom and never spoke with them. Jonathan said he was inside of the residence when he heard what he thought was Christopher working the slide of the handgun. Jonathan said that he did not think anything about this because Christopher had messed with the gun several times before while they were at the residence. Jonathan said that all three of them along with Jamie then went outside to the front porch. He said that while on the front porch Christopher suddenly came out of the residence and immediately started shooting at them.

Jonathan said that he took off running, and was shot in the left side of the head and the left leg. Jonathan then came back to find Alyssa and Daultn had been shot.

Your affiant returned to 1814 West Maine at 10:42 P.M. on June 25th, 2016 and served a search warrant. The warrant was signed by Judge Lovell. During the search of the residence a Smith and Wesson M&P 9mm handgun was located on the kitchen table inside of the residence. The magazine to the gun was located beside the gun. The gun was chamber loaded and the magazine had 13 rounds in it. During the interview with Christopher he stated that the gun would have 14 rounds with it, and he stated that it held 18 rounds. Christopher said that he had fired four rounds from the gun which matched what we found at the scene.

On June 27th, 2016 your affiant spoke with Alyssa Cull at the OU Medical Center in Oklahoma City, Oklahoma. Alyssa said that she, Jonathan, and Daultn had went to the residence on Maine to speak with Jamie. Alyssa said that after being at the residence for several minutes they had left and walked outside to the front porch. Alyssa said that while in the residence Christopher never spoke to them. Alyssa said that Christopher was in his bedroom on the floor while they were inside. She said that shortly after walking outside to the porch Christopher came out the door and started shooting at them. She said that she was not sure if Daultn or Jonathan was shot first, but said that she was shot second. She said that after being shot in the chest she went off the porch and collapsed next to the residence to the east of Jamie's. Alyssa said that while she was on the ground she was able to see Daultn and noticed that he had a large amount of blood on his back. She said that she knew that he had also been shot.

Based on this information, the undersig finding of fact that probable cause to believe t crime.	hat the defendant above named committed that Sol
