## STATE OF OKLAHOMA, COUNTY OF KINGFISHER:

I, Tommy Humphries, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Kingfisher and in the State of Oklahoma, **Hui Tang**, did then and there unlawfully, willfully, knowingly and wrongfully commit the crimes of:

COUNT 1: AGGRAVATED MANUFACTURE OF A CONTROLLED DANGEROUS SUBSTANCE (MARIJUANA) ~ A FELONY. On or about the 29th day of May 2025, at 6085 E. 780 Road, Kingfisher, in Kingfisher County, Defendant Hui Tang jointly and in concert with others, illegally manufactured in excess of 1000 marijuana plants, marijuana being a controlled dangerous substance in Schedule I of the Controlled Dangerous Substances Act of Oklahoma, contrary to the form of the Statutes in such cases made and provided and against the peace and dignity of the State of Oklahoma.

COUNT 2: POSSESSION OF A CONTROLLED DANGEROUS SUBSTANCE WITH THE INTENT TO DISTRIBUTE (MARIJUANA) ~ A FELONY. On or about the 29<sup>th</sup> day of May 2025, at 6085 E. 780 Road, Kingfisher, in Kingfisher County, Defendant Hui Tang possessed marijuana, a controlled dangerous substance in Schedule I of the Uniform Controlled Dangerous Substances Act, with the intent to distribute said marijuana, contrary to the form of the Statutes in such cases made and provided, and against the peace and dignity of the State of Oklahoma.

COUNT 3: POSSESSION OF UNLAWFUL PROCEEDS ~ 21 O.S. § 2001, A FELONY. On or about the 29th day of May 2025, 6085 E. 780 Road, Kingfisher, in Kingfisher County, Defendant Hui Tang, acting alone and with others, knowingly acquired and concealed funds or engaged in transactions involving funds knowing that those funds were derived from unlawful activity, to wit: possess of marijuana, a controlled dangerous substance, with the intent to distribute, contrary to the form of the Statutes in such cases made and provided and against the peace and dignity of the State of Oklahoma.
