Long Term Strategic Plan Progress

LTSP Priority 3- Partnership & Outreach

Goal 1: Partner with other local organizations to provide relevant and high quality services to the residents of Garfield County.

The library is partnering with the Public Arts Council of Enid (PACE), the Parks Board and the Parks department, and the Oklahoma Tobacco Settlement Endowment Trust (TSET) to bring a permanent StoryWalk® to Champlain Park.

A StoryWalk® is a book placed in a park or other public space that encourages families to walk together interacting with the story. Most often these are children's books. Books are dismantled to share one page, or one 2 page spread at a time and placed in order along a trail. There are sometimes additional activities associated with each page to encourage interaction and additional movement. The program encourages families to be active outside together while also encouraging reading and sharing of stories.



The library hosted a temporary StoryWalk® during Summer Reading 2022. The new project will include permeant structures instead of temporary signage.

The library will be responsible for maintaining the story portion of the StoryWalk® including replacing stories periodically and creating monthly events to promote participation. The library will also be working to create additional accessibility features such as audio tracks for each page. These audio tracks will be available through the use of QR codes. The library will track participation at hosted events and attempt to track participation as community members interact with the StoryWalk® throughout each month.

The StoryWalk® Project was created by Anne Ferguson of Montpelier, VT and developed in collaboration with the Kellogg-Hubbard Library. Storywalk® is a registered service mark owned by Ms. Ferguson.

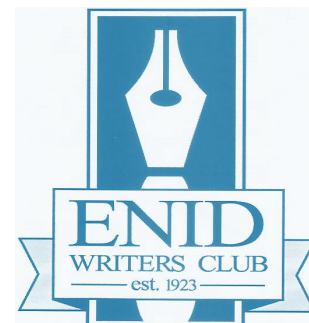
Goal 3: Lifelong Learning and Programming; Objective 2: Establish periodic events to enhance appreciation of the arts and literary expression or allow for the development of such skills



Enid Author Fest is an annual event at the library that started in 2017. Each spring since, with the exception of 2020 and 2021, the library has hosted authors from Enid and through out Oklahoma. The event takes place on the library floor and gives local authors a chance to meet other authors and readers alike. The authors are allowed to sell their books at the event. Currently, there are 26 authors registered for the event. There is room for additional authors to join us.

This year in conduction with the Author Fest we will also be celebrating the 100th Anniversary of Enid Writers Club. The Enid Writers Club is oldest club writers club in Oklahoma. The club began in 1923, headed up by Professor Roy J. Wolfinger of Phillips University, and has strong ties to the Public Library of Enid and Garfield County.

A reception will be held in the Marquis James Room from 12:00-1:00 on Saturday, April 15. The club will present a beautiful ceramic plaque commemorating the 100th anniversary. The plaque was hand-sculpted by Oklahoma artist Nancy Russell.



Several members of the Enid Writers Club will be at Author Fest with their published works.

Recent Large Scale Technical Services Projects

Young Adult (YA) Collection Assessment

The leadership team at the library created a new standard for collection assessment specifically related to the teen section of the library. In response to feedback from the community the library has decided that books shelved in the YA should be limited to those books appropriate for readers 16 years of age or younger. The technical services department was responsible for checking the age recommendations of the more than 4,000 titles in the teen section of the library.

Moving books from one section to another requires that each book be removed from the shelf so that the spine labels can be removed and replaced. Additionally, the catalog needs to be updated with the new call numbers and shelf locations. The process is labor intensive; our tech services team worked efficiently to cross reference the YA collection and move more than 300 books. Our team was able to complete this project in less than three weeks.

Series Assessment

The technical services team is currently working on cleaning up the series identifiers on all the books in the library collection that are part of a series.

To make finding the next book in a series easier for patrons, we include series labels on the spine labels and in the catalog. Previously, fiction books by the each author were organized by title. This means the books for each series were not labeled as such and were not necessarily next to each other. Last year we added series names to spine labels and in the catalog to make finding the next book in the series easier for patrons.

Some of the records for new books come with series titles that are not exactly identical to what we have listed in our catalog. The technical services team is currently working through all catalog records to make sure we do not have errors in the series identifiers. This project is expected to take up to two months.

This poster exhibition was designed to educate and inspire young people to see themselves as future inventors.



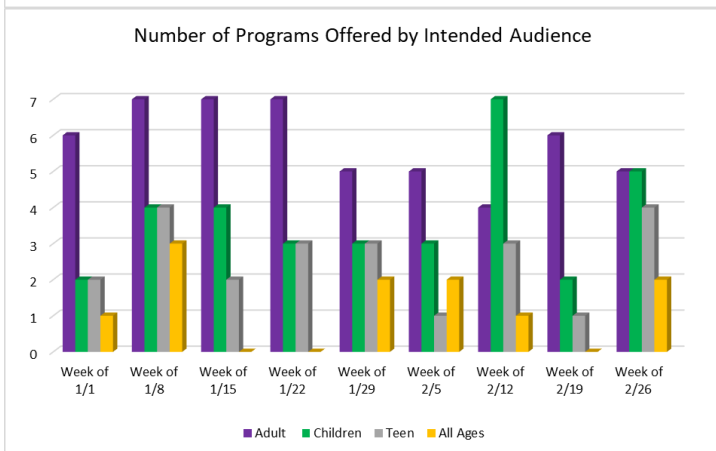
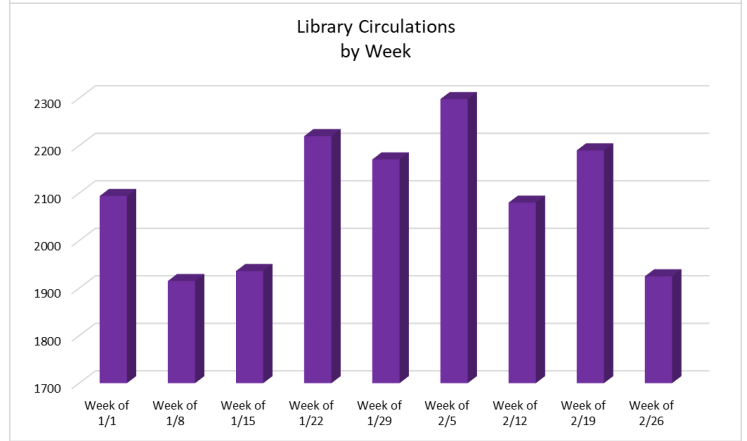
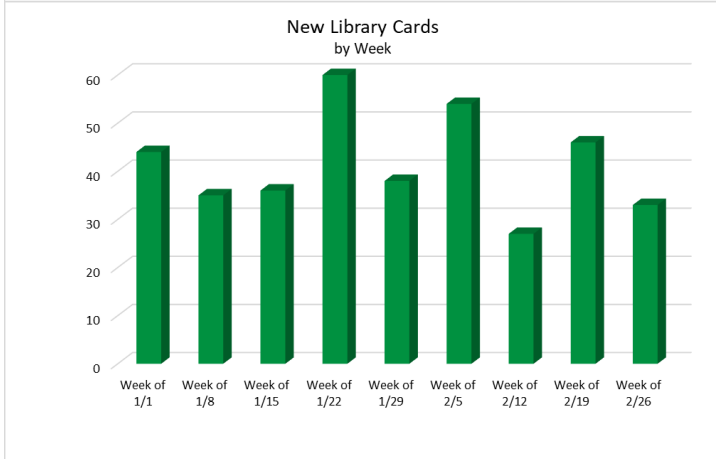
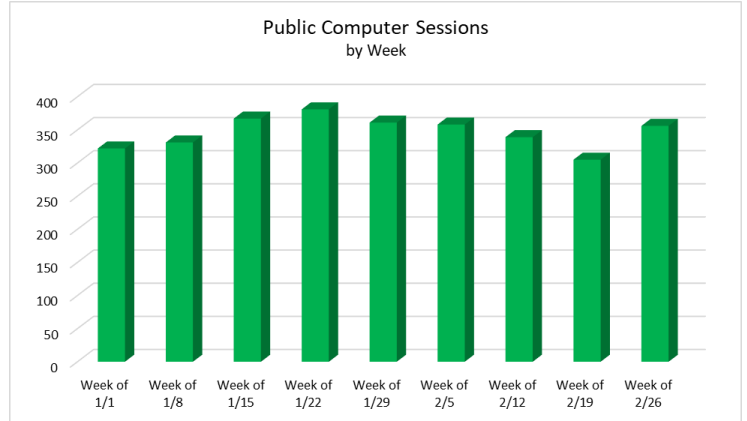
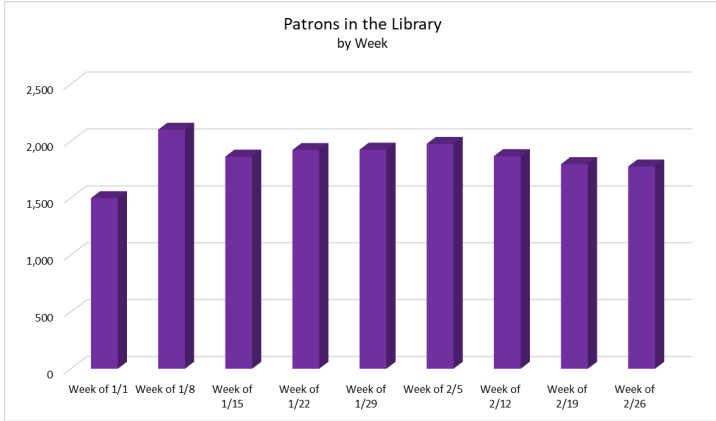

The Smithsonian and the United States Patent and Trademark Office present "Picturing Women Inventors," a poster exhibition that explores the inventions of 19 highly accomplished American women. The exhibit will showcase the breakthroughs, motivations, and challenges women encountered while pursuing their goals as inventors.

"Picturing Women Inventors" highlights stories of inventors like Marilyn Hamilton, who after a hang-gliding accident in 1978 left her paralyzed, invented a lightweight wheelchair that was easy to maneuver. Diversity of background and age are showcased including inventor Alexis Lewis, who at 12-years-old in 2011 was inspired to adapt a traditional Native American sled, called a travois, by adding wheels to create a simpler way to transport families and their belongings in Somalia.

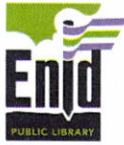

Outside Entity Use of Display Area for Exhibits

1. The Library does not sponsor or endorse the subject matter of the Exhibits.
2. The Library will not restrict Exhibits to include political or sectarian content. All Exhibits will be considered in terms of acceptable community standards and Library Policies including, but not limited to subject, technique and style suitable for the general Library audience, including minors. The Library will not accept Exhibits that are obscene or harmful to minors¹.
3. Due to the Library's small size and open floorplan, all Exhibits must be appropriate for a general audience, including children.
4. Exhibits must be offered to the Library at no cost and the Library assumes no responsibility for lost or damaged items.
5. No Exhibit may include a request for a donation.
6. Exhibits are temporary and the length of time an Exhibit may be in place depends upon the demand for space. Generally, the Exhibit will be in place for no more than four weeks.
7. All Exhibits shall include a sign identifying the person or group who is sponsoring the Exhibit. While the Library does not sponsor Exhibits, the Library will provide information for patrons about the subject of the Exhibit, its location, and duration.
8. The person or group seeking to place an Exhibit must complete and submit the PLEGC Exhibit Request Form (paragraph 5.15) to the Library at least four months before the proposed Exhibit date.
9. The Library Board will review all PLEGC Exhibit Request Forms and choose from the selection. The Library Board has the discretion to accept, postpone, or refuse a request for an Exhibit based on this policy, space available, encouraging variety from previous or ongoing Exhibits, current Library emphasis areas, the Library Mission, Library Policies, etc. (Note – Exhibits currently displayed or on request at the time this policy is adopted are exempt from this rule.)
10. If an Exhibit is selected, the Exhibit will use the space designated by the Director. Shelves and endcaps are reserved for Library Displays only.
11. The Library Board may reject an Exhibit that does not conform to these conditions and may restrict the use of items that are a risk to public health, morals, safety, and welfare.
12. Disputes over Exhibits may be appealed utilizing the Library Appeals Process.

¹ Obscenity means and includes any representation, performance, depiction or description of sexual conduct, that contains the following elements:

- depictions or descriptions of sexual conduct which are patently offensive as found by the average person applying contemporary community standards;
- taken as a whole, have as the dominant theme an appeal to prurient interest in sex as found by the average person applying contemporary community standards;
- and, a reasonable person would find the material or performance taken as a whole lacks serious literary, artistic, educational, political, or scientific purposes or value.

21 O.S. §1024.1

Material harmful to minors means: any description, exhibition, presentation or representation, in whatever form, of inappropriate violence or that quality of any description, exhibition, presentation or representation, in whatever form, of nudity, sexual conduct, sexual excitement, or sadomasochistic abuse when the material or performance, taken as a whole, has the following characteristics:

- the average person eighteen years of age or older applying contemporary community standards would find that the material or performance has a predominant tendency to appeal to a prurient interest in sex to minors,
- the average person eighteen years of age or older applying contemporary community standards would find that the material or performance depicts or describes nudity, sexual conduct, sexual excitement or sadomasochistic abuse in a manner that is patently offensive to prevailing standards in the adult community with respect to what is suitable for minors, and
- the material or performance lacks serious literary, scientific, medical, artistic, or political value for minors.
