Vendor must agree to a minimum 98% uptime for equipment. Uptime is defined as the percentage of time the machine is on-site, operating according to specifications and fully available for use by the customer during the hours of 7:00 a.m. to 5:00 p.m. Monday through Friday. 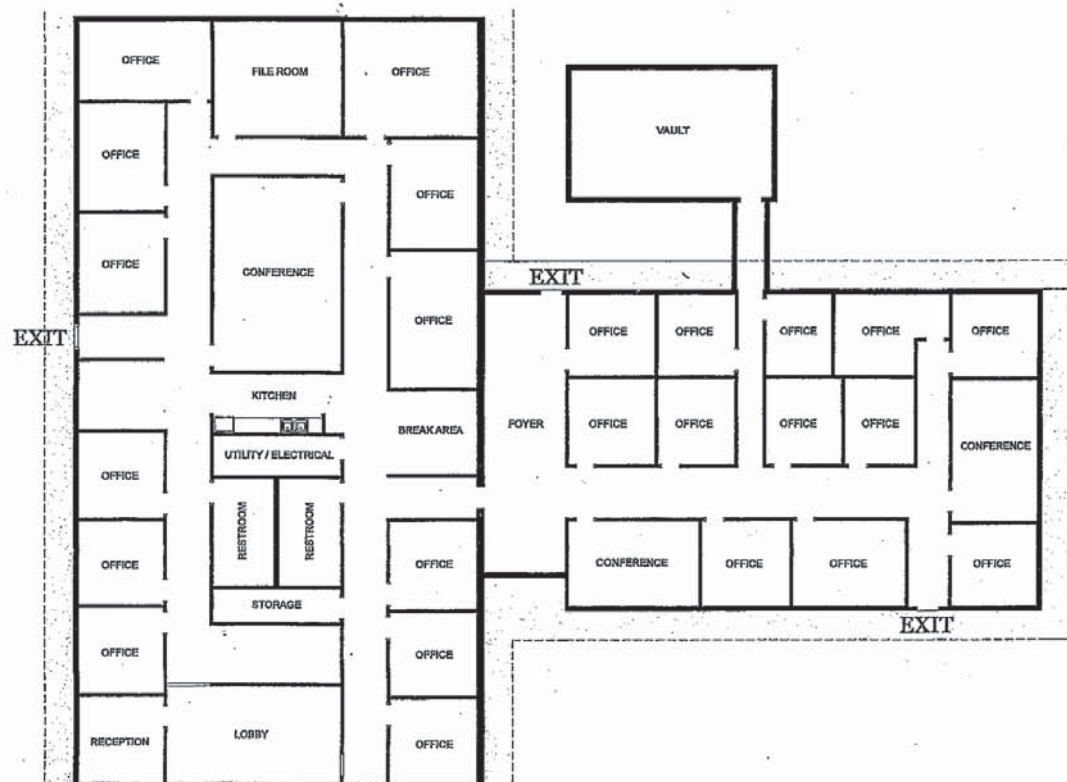
