Subject: Internal Investigation (IA# 2022-9808) – Violation of G.O. 305 & 308

Introductory Paragraph:

On Thursday, April 21, 2022, at 11:55 hours, I was directed by Chief Michael Passalacqua to commence an internal investigation into an inappropriate computer background image. The background image, a collage photograph of Ward 5 Geneva City Councilor Laura Salamendra's face with the letters "GPD" on her forehead, was displayed in the booking area at the Public Safety Building. A photograph was taken on an unknown date and time by an unknown person. The photograph was then obtained by Laura Salamendra. During a press conference on Wednesday, April 20, 2022, Laura Salamendra displayed a poster board sized image of the booking area and an up-close image of the computer background.

On Thursday, April 21, 2022, at 14:18 hours, I sent the following email to all members of the Geneva Police Department: "All, At the direction of Chief of Police, I am tasked to conduct an internal investigation into Laura Salamandra's complaint that she made on April 20, 2022. If you are not aware of her complaint, she displayed a photograph of our booking area at a press conference before last night's City Council meeting. The image further showed one of our computers with a background image of Laura's face with the letters "GPD" on her forehead. With this said, I am asking for the following: Do you have any knowledge of who created/displayed the background image? Do you have any knowledge of who took the photograph of our booking area? I am asking that any and all information be directed to me, and me only. You can call me at 315.414.6513, see me in person or email me. Thank you all in advance." I gained two (2) responses from this email. One from Officer Richard Baskin and one from

The City of Geneva Police Department's General Orders Section 305 Rules of Conduct and Section 308 Acceptable Use of Technology covers numerous topics. Specifically, these sections address unbecoming conduct and unacceptable uses of city technology.

Findings Section for the Specific Violations:

The following information is alleged by witnesses, which are citizens, City of Geneva employees and sworn members of the City of Geneva Police Department:

Press Conference at Jordan Hall (April 20, 2022):

A press conference was held at Jordan Hall in the City of Geneva on April 20, 2022. The press conference was put on by members of the City of Geneva's Police Review Board and citizens. During the press conference, members of the P.R.B. and citizens spoke. This press conference was live streamed on the Geneva Women's Assembly Facebook page.

During the press conference, a male speaker, Ricky Price, explained that Laura Salamendra had a complaint against the Geneva Police Department. While Ricky Price spoke, a female, Hannah Dickenson, held up a poster board sized display which showed two (2) images, and a heading (or title). The heading read, "Geneva Police Department Computer Booking Area of the Public Safety Building." The first image displayed a close-up photograph of a booking area computer, which is located in the P.S.B. The computer screen showed a collage style background image of Laura Salamendra with the letters "GPD" on her forehead. The second image showed an overall photograph of the booking area, which displayed the computer and the computer's background.

Ricky Price alleged that someone from the Geneva Police Department created and displayed the computer background. Ricky Price indicated that only one person had the "good sense" to know the image was wrong. Ricky Price said the individual did not change the computer's background, but did share the photograph so the public would know what goes on in the Geneva Police Department. Ricky Price indicated that this image shows part of a course of harassing conduct against Laura Salamendra by members of the Geneva Police Department.

Laura Salamendra also spoke during the press conference. Laura Salamendra predominately spoke about the P.R.B. Laura Salamendra said she has several complaints from the community against the Geneva Police Department. Laura Salamendra said, "I have a complaint to bring to the P.R.B. I have a complaint of my own." In sum and substance, Laura Salamendra said she has been harassed by the Geneva Police Department. Laura Salamendra said the computer's background image is part of that harassment.



Response Letter from City of Geneva Police Officer Richard Baskin:

"Lieutenant Colton,

I am responding to your request to the matter of an image of Ms. Salamendra. I offer this response under my own free will and have not been counseled as to how to respond. My answers to the following questions are included.

1. When did you create the background image? If not you, who created the image?

As you may recall, during the spring of last year, Laura Salamendra along with several others came to the Public Safety Building to protest. It is their right to do so. While protesting, Laura Salamendra and other wrote in chalk, "ACAB" (All Cops Are Bastards), "You are not heroes", "GPD quit your jobs", "Stop killing kids" and so on. I was working that night, and witnessed this from inside the PSB. I was reluctant to even leave the PSB for fear of abuse by these people. After this, no one reached out to me either from City Council or the Department. I felt anger, and was upset. I have never killed a kid and I am no bastard. I am also no hero. After this disgusting event, I created the image of the councilor. I used a public image and emblazened the "GPD" on her head. It was my way of showing frustration after the councilor had put such disgusting remarks on City property.

2. When was the background image initially displayed on the computer(s), and for how long?


As stated in my first answer, it was about the time after Councilor Salamendra wrote those gross words and phrases at the PSB. The image was on one computer, which is depicted in the image that Councilor Salamendra displayed at her press conference.

3. Why did you create the background image?

I would like to add that at no time was this image left for others to see, except for the time the photo was taken from inside the dispatch office. It was never displayed on the booking computer. I understand that this form of protest may be unorthodox and even not wanted. I should have been above the noise and moved on. But, unfortunately, I didn't. For that, I am sorry. It sullies the good name of every Officer that has served before me, along side of me and in the future. The image has since been deleted at my hand. It is my belief, that as juvenile as this may be, the actions of Councilor Salamendra last spring far outweigh that of this image. I am including an image from that very protest to add context.

Evidence to Support the Specific Allegations:

Evidence to Refute the Specific Allegations:

There is no evidence to refute the allegations.

Identification & Explanation of Allegations:

Geneva City Police Officer Richard Baskin created a collage image of Geneva City Ward 5 Councilor Laura Salamendra with the letters "GPD" scribed on her forehead. Officer Baskin displayed the image as a computer background on a booking computer located inside of the Public Safety Building. Officer Baskin indicated that he created the image as a direct result of citizens, including Laura Salamandra, scribing in chalk statements against the police department, which occurred at the Public Safety Building during 2021. These statements included, but are not limited to; "ACAB," "You are not heroes," "GPD quit your jobs," and "Stop killing kids." Officer Baskin indicated that he was frustrated with the statements, and showed his anger/disappointment through the computer background image. The computer background image was limited to one computer inside of the Public Safety Building. The background image on the computer was only displayed when Officer Baskin used his login ID. The particular computer and the location of the computer is not accessible to the public.

Furthermore, the City of Geneva's IT Department was unable to determine when the image was created or displayed. Indicated that he observed the background image while he was logging out of booking area computers. It is unknown who captured the photograph of the booking area, and the booking computer. The background image has since been deleted by Officer Baskin.

This is a violation of General Order Section 305 Rules of Conduct III 2(a) – Unbecoming Conduct, which states, "Officers shall conduct themselves at all times, both on and off duty, in such a manner as to reflect most favorably on the department. Conduct unbecoming an officer shall include that which brings the department into disrepute or reflects discredit upon the officer as a member of the department, or that which impairs the operation or efficiency of the department or officer."

Officer Baskin's decision to create and display an inappropriate computer background image in the Public Safety Building does not reflect favorably upon himself and/or the Geneva Police Department. Officer Baskins actions brought the department into disrepute and reflected discredit upon this agency.

This is <u>a violation</u> of General Order Section 305 Rules of Conduct III 39(a) – Use of **Department Equipment**, which states, "Officers and employees shall utilize equipment only for its intended purpose, in accordance with established departmental procedures, and shall not abuse, damage or lose department equipment. All department equipment issued to officers shall be maintained in proper order.

The booking area computer that Officer Baskin used to display the background image is not the intended purpose of said city owned equipment.

This is <u>a violation</u> of General Order Section 308 Use of Technology IV 6(a), which states, "Accessing, displaying, uploading, downloading, viewing, reading, transmitting, circulating, saving, storing, distributing or possessing any form of material of a nature that is pornographic, sexual or erotic (as defined in Section IV (4)(a) of this policy); that is obscene, lewd, or offensive; or that promotes violence, hatred, abuse, neglect or harassment."

The background image that Officer Baskin created and displayed on a city owned computer, according to Laura Salamender's statement, did promote that of hatred and harassment towards her.

This is <u>a violation</u> of General Order Section 305 Rules of Conduct III 1(a), which states, "Officers and employees shall not commit any acts or omit any acts which constitute a violation of any of the rules, regulations, directives or orders of the department, whether stated in this General Order or elsewhere."







After completion of the investigation, Lieutenant Colton came to the following conclusion, which after review, my office is in agreeance with it as it pertains to this investigation:

- 1. You violated General Order 305 III (2a) of the Geneva Police Department
- 2. You violated General Order 305 III (39a) of the Geneva Police Department
- 3. You violated General Order 308 IV (6a) of the Geneva Police Department

This investigation was started by my office after an April 20, 2022 press conference put on by the Geneva Women's Assembly that was held at Jordan Hall prior to the start of a Special City Council Meeting. During that press conference, a photo was revealed of a Geneva Police Department booking computer in the Public Safety Building that dawned a background image of Ward 5 Councilwoman Laura Salamendra's face with "GPD" written across her forehead. This photo was taken by an unknown source. The press conference was streamed live on social media and was also attended by members of the public. The following day, Thursday, April 21, 2022, I directed Lieutenant Colton to commence an internal investigation into this matter. As part of the investigation, Lieutenant Colton sent out a department wide email asking anyone with information/knowledge of the photo to come forward. You responded to that email by sending Lieutenant Colton a text message that same day at 1436hrs indicating that the background photo was your background.

In a response letter to Lieutenant Matthew Colton, you stated that after a protest at the Public Safety Building, in which Councilor Salamendra was present for, where sidewalk chalk was used to scribe phrases such as "ACAB", "You are not heroes", "GPD quit your jobs", "Stop killing kids", you created the

image of the Councilor. In your response letter, it should be noted that you also offered the following:

"I would like to add that at no time was this image left for others to see, except for the time the photo was taken from inside the dispatch office. It was never displayed on the booking computer. I understand that this form of protest may be unorthodox and even not wanted. I should have been above the noise and moved. But, unfortunately, I didn't. For that, I am sorry. It sullies the good name of every Officer that has served before me, along side of me and in the future. The image has since been deleted at my hand. It is my belief, that as juvenile as this may be, the actions of Councilor Salamendra last spring far outweigh that of this image. I am including an image from that very protest to add context".

As a Police Officer, we are held to a higher standard both personally and professionally. As the Chief of Police, I have always expressed that under my direction, the entire Department and all it's sworn membership will be held accountable for their actions. As you stated in your response letter, you should have been above the noise and moved, but did not. Being above the noise is the expectation that I have for you and all of our co-workers. Being above the noise is what makes us professional and holding ourselves to that higher standard. We have the ability to control our own actions, not the actions of others. I too, do not agree with any of the phrases that were scribed on the sidewalk. However, the actions of the Councilor and others that were present, do not excuse the unprofessionalism exhibited by the photo you then placed as your background. Due to this image being originated by you, placed on a departmental computer by you, and ultimately making its way into the public eye, the Police Department including the Office of the Chief of Police, has been brought into disrepute, a negative light, and seen as being unprofessional. As the Chief of Police, I will not stand for any of the above and you will be held accountable for your actions.

Disciplinary action is based on and in accordance with current Geneva Police Officers contract language, specifically Article 19.

Conclusion of Disciplinary Action: I am offering Summary Discipline amounting to **three (3) full days** without pay and any future violations of this type may result in further progressive discipline. Please respond back to my office in writing by the end of the business day on Thursday, May 26, 2022 regarding your decision consistent with contract language in Article 19.2 of the Geneva Police Officers current contract.



Summary of Complaint Process

- The complaint can be downloaded from the City of Geneva website: www.cityofgenevany.com (type in "Complaint" in the Search Box) or picked up at Geneva Police Department, 255 Exchange Street, Geneva, New York or the City Clerk's Office, 47 Castle St., Geneva, New York.
- After completion of the form it should be signed in front of a Sergeant or Lieutenant of the Geneva Police Department or the City Clerk or Deputy City Clerk at City Hall.
- After your complaint has been filed, it is assigned and investigated and given a Case Number. All available witnesses will be contacted, and any physical or other relevant evidence including records, reports, recordings and computer data will be collected and reviewed. You will be personally contacted by a Lieutenant or another person designated by the Chief of Police.
- Once the investigation is completed, the investigation and its report will be forwarded to the Chief of Police for final disposition of the case. When a complaint is sustained, the Chief shall determine and administer appropriate corrective and/or disciplinary action.
- Department policy requires that the complaint investigation to be completed within 45-60 days; however, the Chief of Police can waive the time frame depending on the complexity and sensitivity of the investigation.
- After the investigation has been completed and the Chief of Police has made a final decision on the case, you will be notified of the results by mail.

Most Often Asked Questions

- HOW DO I FILE A COMPLAINT? We would prefer to talk with you about your complaint in person; however complaints will be accepted by mail or in person at the Police Department or City Hall.
- WHAT IS A COMPLAINT? A complaint is a belief that a member of the Geneva Police Department has violated a Department Rule or Procedure, a federal or state law, an ordinance of the City of Geneva, or dissatisfaction with a policy or procedure of the Geneva Police Department.
- WHAT DOES THIS PROCESS NOT HANDLE? This process does not litigate or decide the outcome of any
 parking, traffic, criminal or non-criminal offense. These questions should be directed to the court of
 jurisdiction or your own legal counsel.
- WHO CAN MAKE A COMPLAINT? Anyone can file a complaint if they truly and honestly believe a police employee has acted improperly.
- WHO INVESTIGATES A CITIZEN COMPLAINT? Complaints of alleged misconduct are investigated by members of the Department who are certified to conduct Internal Affairs Investigations. The investigation is then reviewed by the Chief of Police and Personnel Office if needed.

- employee is found to be at fault the complaint will be SUSTAINED and the appropriate corrective and/or disciplinary action will be taken. If they acted properly, they will be EXONERATED. If the facts show that the complaint is false, the complaint will be unfounded. In those cases where the department is unable to determine the validity of the complaint and cannot arrive at any other conclusion, the complaint will be NOT SUSTAINED. If the investigation concludes that the involved employee's conduct was not misconduct but rather an issue of department service or procedure, your complaint will be satisfied as such. In cases of department service or procedure, Geneva Police Department will attempt to clarify or correct the issue.
- WHAT IF MY COMPLAINT INVOLVES CRIMINAL BEHAVIOR? The Ontario County District Attorney's Office may be consulted on any complaint that alleges criminal investigation while the internal investigation is pending.
- WILL I BE TOLD THE RESULTS OF THE INVESTIGATION? YES At the conclusion of the investigation
 and review by the Chief of Police, you will be notified of the results by mail. Due to contractual and legal
 restrictions, you will be only be given the finding of the investigation of whether your complaint was
 SUSTAINED, UNFOUNDED, EXONERATED, NOT SUSTAINED, OR IS ONE OF DEPARTMENT SERVICE OR
 PROCEDURE. The department is prohibited from revealing specific personnel actions taken against the
 employee.
- CAN I GET IN TROUBLE FOR MAKING A COMPLAINT? NO Every citizen has the right to file a complaint, if it is done in good faith, with an honest belief that an employee of the acted improperly. If a false statement is made you may be charged under the NYS Penal Law Section 210.45.
- ABOUT THE COMPLAINT FORM. The attached form should be used to file your complaint. You can
 attach as many additional pages as necessary, along with any supporting evidence you may have. After
 you complete the form bring it to the Geneva Police Department or the City Clerk's Office or mail it to:

This is an official complaint regarding the screen saver image that appeared on a police department computer showing a defaced portrait of Laura Salamendra, who sits (along with myself) on the City Council. The image showed her face with a tattoo-like "GPD" across her forehead. It is duplicated several times across the screen. My understanding is that the computer was in the booking room, a common area used by multiple officers.

My complaint is against whoever created and posted this image, as well as all officers who saw it and did nothing to have it removed. I make the complaint on behalf of myself as a fellow City Councilor and resident of Geneva, and on behalf of all Geneva's citizens, who expect and deserve a professional, fair-minded and mature police department serving this community.

The fraternity house mentality that would prompt the creation of this image and the acceptance that kept the image on the screen cannot be tolerated. It rings of retaliation against an individual who has been critical of the police. It shows a complete lack of respect for an elected official. It is completely beneath what any reasonable person would expect from police, and it degrades public trust in the department.

To be clear, the images come across as a harassment, and were threatening in tone. My first impression of the markings imprinted on Ms. Salamendra's forehead was its resemblance to a bullseye for shooting. My second impulse was to compare it to a brand, another violent concept. I think it is hard not to draw these conclusions when seeing this image.

This incident left a Geneva citizen questioning her safety when around members of your department, and caused many others to lose some faith in the way the department conducts itself.

I will look forward to learning what was behind this appalling scenario, and what approach will be taken to ensure this remain a singular event.


