PRESIDENT WILSON'S CABINET MET THIS MORNING LEWIS ADMITS MINERS COMPLY WITH ORDER UNDER PROTEST

INDIANAPOLIS, Ind., Nov. 11.—Officials of the United Mine Workers after an all-night session voted early today to call off the coal strike.

The decision to obey the court order of Federal Judge A. B. Anderson was reached shortly after 4 o'clock, after seven hours of deliberation.

Stormy scenes were said to have accompanied the long session, but the conservatives finally won out.

The miners had until noon today to reply to the Federal court mandate.

After adjournment had been taken until 2 o'clock this afternoon, John L. Lewis, acting president of the United Mine Workers of America, made the formal announcement of the decision.

"We are American citizens and we would not undertake to fight the government," declared Mr. Lewis to the assembled reporters.

"We have decided to comply with the court's mandate, but we shall do so under protest. That is all I can say."

Mr. Lewis then hurried away with other officials of the union.

The officials of the union had conferred all day Monday on the momentous question affecting not only the future of the industry of the 425,000 bituminous miners, but the industry of the country.

A strong fight was made by the radical element. The leaders of this wing of the union demanded that the government be defied. They contended that the time had come for a showdown.

These radicals were answered at length by the conservatives who pointed out the tremendous consequences of a strike.

Judge Anderson Approves Strike Recall Order

INDIANAPOLIS, Ind., Nov. 11.—Today in an all-night session in the United States, the coal strike will be called off.

Judge Albert B. Anderson in Federal court at 10 o'clock this morning approved the recall order submitted by the United Mine Workers of America.

At an all-night session, a little less than 100 officials of the United Mine Workers of America, who were in the industrial future of the country or the destiny of the nation in the future, decided to make peace between the labor and the government.

mal conditions, however, it was admitted by the government. Immediate Negotiations Probable.

It is very probable that the miners now will await the actual issuance of the proclamation of peace by President Wilson before they attempt further adjustment of their wage scale, it was held in some circles. In other quarters, however, the belief was general that surrender of the miners at this time will pave the way for immediate negotiations with the operators.

International officers of the mine workers were silent after the conference adjourned at 4:15 this morning, declining to comment on any phase of the suddenly altered situation. That their plans may become known, however, when they present the recall order for the court's approval was the hope of the government.

"A majority of the delegation came to this meeting smarting under the bitterness of the government's action, Acting President Lewis of the Mine Workers said today. They were loyal American citizens. They were convinced that the action taken was the thing to do. The recall order has gone forth. I cannot say how many will return to work. I do not know, as to what action will be taken in the immediate future, I refuse to even harbor a guess."

Mr. Lewis said the members of the conference had remained in Indianapolis to attend a Policy meeting to be held this afternoon.

In his statement today Mr. Lewis admitted the assertion that the miners are complying with the court mandate "under protest."

At the close of the conference he announced: "Gentlemen: We will comply with the mandate of the Court. We do so under protest."

Cabinet Held Meeting. Washington, Nov. 11.—President Wilson's cabinet met at 10 o'clock today—armistice day—cheered at the first step in a peace move by the great body of striking coal miners.

President Wilson was expected to issue a statement later in the day on the government's position in the coal strike situation, once the miners have complied with the coal order. Secretary Tumulty intimated strongly that such a statement would be forthcoming.

"The miners have taken the proper course," said Secretary of the Treasury Glass, who was the first to arrive at the meeting. After the meeting of the Cabinet Attorney General Palmer made a statement in connection with the coal strike.

"My information is that the miners have submitted to the court the form of an order cancelling and withdrawing the strike order. The strike order, having been set aside, the Secretary of Labor will today invite the operators and miners to meet immediately in conference to negotiate an adjustment of their contract."

The way is now open to a settlement by peaceful processes which should always be employed in the settlement of such disputes without injury to the general public.

LEGION READY FOR A STORY SESSION TODAY

Fights Expected Over Resojution of Military Preparedness Committee and Bonus Problem

Minneapolis, Minn., Nov. 11.—The American Legion was in for a stormy session today with verbal battles in sight when resolutions drawn up during all-night sessions of the various committees are presented to the convention for a vote.

One of the biggest fights is expected on a resolution from the military preparedness committee attacking the Chamberlain-Kahn bill and demanding an immediate revision of the military system of this country.

Another verbal fight is anticipated over the bonus problem. Many of the delegates favor the adjustment of pay of the American soldiers, sailors and marines at an amount to be fixed by the legion and submitted to Congress.

Others say "let Congress fix the amount."

California's fight for anti-Japanese legislation was another "hot" problem which the legion expects to tackle late today.

The race for national commander in chief has been narrowed down to three candidates—Edward L. Hogan of Boston, Franklin D. Oiler of Pennsylvania and Luke Lee of Tennessee.

Russia Was To Aid Germany in Communist Revolution

Berlin, Nov. 11.—Detailed plans for a communist revolution in Germany, with the assistance of Russia, were said today to be in possession of the police and military authorities as a result of the recent raid on communist headquarters at Muenchenberg, during which a number of arrests were made.

Amsterdam, Nov. 11.—An American steamship, believed to be the Ampeter, is ashore off the coast of Holland.

ARMISTICE DAY CELEBRATED IN WASHINGTON

Washington, Nov. 11.—Popped up in his bed President Wilson today expected to watch from a White House window the first celebration of the end of the great war.

The celebration will be held in historic Lafayette Square, just opposite the White House.

An ardent prayer, offered by Lieutenant Belvin Maynard, "the flying parson," was to be the feature of the celebration. Lieutenant Maynard was to offer a prayer by wireless telephone from an airplane circling over the park.

A volley of 48 shots from 48 rifles, fired by soldiers, sailors and marines from 48 states was to be discharged at one minute before 12—the hour when peace came to the world one year ago.

Vice President Marshall and other high dignitaries were to take part in the planting of a tree in memory of the men who fell in battle.

In the school yard of the Forde school, small students of that institution will plant a tree in memory of Quentin Roosevelt, who attended the Forde school when a small boy of the White House.

For 11 months all Washington will cease its work and sing songs of praise—then work will go on and the nation's capital will have completed its celebration of the first anniversary of the war's end.

GOVERNMENT FACES ANOTHER LABOR CRISIS

Hines Met With Chiefs of Four Big Railway Brotherhoods Today

Washington, Nov. 11.—With the dawn of peace in the confederation of the government today was facing another labor crisis.

Director General Hines of the railroad administration was today meeting with the chiefs of the four big railroad brotherhoods, preparatory to answering their demands for increased wages.

No inkling has come from the railroad administration as to just how far the government will go in meeting these demands, but the brotherhood chiefs have been very positive in their demands.

Railroad workers are in a mood that forbodes trouble if they are not given satisfaction in their demands. This is indicated in the returns of a strike vote which has been taken by some of the railroad unions affiliated with the American Federation of Labor.

Thousands of Contracts. The abrupt termination of fighting left us many thousands of contracts in force. Of these, many have been immediately suspended, having a value of \$2,500,000,000.

THE PRICE OF WALES ARRIVES IN WASHINGTON

Washington, Nov. 11.—In a drizzling rain which did not dampen the warmth of the welcome accorded him, the Prince of Wales arrived in the American capital shortly after noon today.

He was heartily welcomed by Vice President Marshall, who, because of the President's illness, received the royal visitor on behalf of the American government.

ONE YEAR AGO PRINCE OF WALES WAS IN FLANDERS. En route to Washington from the Prince of Wales, Philadelphia, Nov. 11.—Armistice day found the Prince of Wales upon a train bound for the first leg of his long American visit.

Just one year ago today the young prince was with the British army in the war-torn fields of Flanders, and it was probable that the next frost struck him strongly on his first day of peace, as his special train sped swiftly through the orderly well tilled fields of New Jersey and Pennsylvania.

The royal visitor rose early and after breakfast, with his suite watched the Jersey landscape go by. He is in excellent health and members of his party say he is extremely interested in his visit to the United States.

Jersey City, N. J., Nov. 11.—The Prince of Wales, fast asleep, paid his first visit to this section of the country early today and today the young prince stopped at the old Pennsylvania station here for 25 minutes. His train, coming from Albany, was switched from the main line to the Jersey City platform and they set up a cheer as the train pulled in.

A group of railroad men had gathered to see the prince. "I greet myself" and were quite disappointed when he failed to appear.

Senate Considers Treaty Reservation

Washington, Nov. 11.—The Senate this afternoon resumed consideration of the peace treaty, with a reservation to Article X of the League of Nations Covenant. This is the reservation which President Wilson referred to as "a certain cut the heart of the Treaty."

"This philosophy has been altered slightly by Senator Hitchcock of Nebraska, who is an objector to the reservation, and the friends of the treaty, who are in the majority, are warring the target for attack by Republican senators when debate on the resolution is resumed.

"By the greatest stretch of the imagination and the use of a magnifying glass I defy any member to point them (fourteen points) out in this treaty. Senator Stewart, Republican, from Wisconsin, said:

"As an American I feel humiliated by the action of the President of the United States in going to Paris and agreeing to a covenant which no person in this country ever wanted or cared about. Senator Penrose, Republican, of Pennsylvania, said:

TNT Wins Contest With Dynamite. A contest was recently waged between 40 per cent dynamite and trinitrophenol, and the latter won, says the Scientific American. Two concrete pillars had to be blasted out and this gave an opportunity for a comparative test of the two explosives, with the result that 14.5 cubic feet of concrete were removed per pound of TNT, and only 14.1 per pound of dynamite.

NEWSPAPER STRIKE IN PARIS. Paris, Nov. 11.—The newspaper work, now struck, went into effect today and only two morning papers appeared.

One was a composite journal, "La Presse de Paris," in which the striking staffs paper had contributed, and the other was the Socialist organ, "Humanite." Police are guarding the newspaper offices.
