On 04/18/23, Victim #1 entered the Rudisill Regional Library located at 1520 N. Hartford Avenue at approximately 0919 hours. Victim #1 proceeded to sit down at a library computer. At approximately 0928 hours, Carlton Gilford (suspect) walked up behind Victim #1 and proceeded to shoot him in the head one time.							
Carlton Gilford exited the library and got into a Gray Ford Taurus with Oklahoma tag! '. Gilford proceeded to the QuikTrip located at 1513 N. Peoria Avenue. Gilford exited the vehicle. While at the QuikTrip, Gilford approached Victim #2 who was at the ATM machine at approximately 0938 hours. Gilford shot Victim #2 in the head. Victim #2 fell to the ground and Gilford proceeded to shoot Victim #2 many more times.							
While at the QuikTrip, Carlton Gilford shot at two employees but neither employee was struck.							
Police arrived on scene and learned the suspect description. Carlton Gilford was located in the QuikTrip parking lot. Police officers made contact with Gilford and placed him in custody. Gilford had a gun in his possession that was consistent with what was used in the two above incidents. Both incidents were captured on video surveillance and Carlton Gilford was positively identified as the suspect.							
Victim #1 was transported to a local hospital and died later that afternoon on 04/18/23. Victim #2 was pronounced dead at the crime scene at QuikTrip.							
The video surveillance showed that there was no interaction or disturbance between Gilford and the two victims prior to him shooting them in the head. Gilford killed both victims unprovoked.							
When Gilford was placed under arrest, officers discovered that Gilford had a gunshot wound in his own head. It appears that Gilford shot himself prior to him being located and arrested. Gilford was transported to a local hospital to be treated for his injury.							
As of 04/18/23, there is probable cause to arrest Carlton Gilford for 2 counts of 1st Degree Murder and 2 counts of Shooting with intent to Kill.							
The above incident occurred in the City and County of Tulsa.
