COUNT 1: CRUELTY TO ANIMALS ~ a FELONY, on or about the 29th day of August, 2023, by willfully and cruelly injuring a English Bulldog that belonged to Arianna Ruiz by tasing it 8 times, spraying him with pepper spray and striking him on the head, causing injury.

COUNT 2: ACTS RESULTING IN GROSS INJURY / OUTRAGING PUBLIC DECENCY~ a MISDEMEANOR, on or about the 29th day of August, 2023, by willfully and wrongfully committing an act that grossly disturbed the public peace by unholstering a firearm and threatening to shoot an English Bulldog.
