INSTRUCTIONAL MATERIALS

The Spotsylvania County Public School Board is responsible for the selection and use of instructional materials.

The superintendent or the designee creates and updates as necessary, guidelines and procedures for the selection of instructional materials. The guidelines and procedures are designed to ensure that appropriate instructional materials are selected and provide an opportunity for the professional staff and community to participate and be informed on the selection and use of instructional materials.

Parents may inspect, on request, any instructional material used as part of their student's curriculum.

Purpose

To establish clear procedures for schools to (i) identify all instructional materials with sexually explicit content, (ii) ensure parental notification of any instructional materials with sexually explicit content, (iii) permit parents to review all instructional materials with sexually explicit content, and (iv) ensure alternative instructional materials, that do not include sexually explicit content, are provided in a non-punitive manner for any student whose parent so requests.

Definitions

Section 2.2-2827 of the Code of Virginia states that "Sexually explicit content" "means (i) any description of or (ii) any picture, photograph, drawing, motion picture film, digital image or similar visual representation depicting sexual bestiality, a lewd exhibition of nudity as defined in Section 18.2-390, sexual excitement, sexual conduct, or sadomasochistic abuse, coprophilia, urophilia, or fetishism.

The Code of Virginia Section 22.1-1 defines "parent" or "parents" as any parent, guardian, legal custodian, or other person having control or charge of a child.

For the purposes of this policy, the phrases "instructional material" and "instructional materials" mean any content used by one or more students for an educational purpose, regardless of (a) its format, whether printed, representational, audiovisual, electronic, or digital (such as materials, social media content, and software applications accessible through the Internet), or (b) the time, place, and manner in which the content is used. All library materials are considered instructional materials. when used (i) for completion of an assignment, or (ii) as part of an academic or extracurricular educational program. This includes any division, school, and/or classroom purchased or created assessments. However, The phrases "instructional material" and "instructional materials" do not include standardized national or state assessments, such as the ACT (American College Testing), SAT (Scholastic Assessment Test), NAEP (National Assessment of Educational Progress), and AP (Advanced Placement), or SOL (Standards of Learning).

Identification of Instructional Materials with Sexually Explicit Content

The leadership at each school shall establish a process for identifying instructional materials with sexually explicit content.

Prior to the start of the academic year, schools identify the specific materials that include sexually explicit content which that may be used during the upcoming school year. When determining whether instructional materials contain sexually explicit content, teachers, principals, and division staff shall consider student age and maturity, and whether a parent might reasonably consider the instructional content harmful to their child.

Notice to Parents

At least 30 days prior to the use of any instructional materials with sexually explicit content, schools shall provide written notice to parents that (i) specifically identifies the instructional materials with sexually explicit content, (ii) informs parents of their right to review such instructional materials, and (iii) informs parents of their route their child use, in a non-punitive manner, alternative instructional materials that do not include sexually explicit content. Such notice shall be provided in writing to parents and families through syllabi, email, newsletters, learning management systems, U.S. Mail, and/or in person at a parent-teacher meeting.

Parental Right to Review of Instructional Materials with Sexually Explicit Content and Right to Alternative Instructional Materials

Principals shall maintain a current list of instructional materials with sexually explicit content by grade and subject on the school's public website.

Principals shall provide online access for parental review of instructional materials that include sexually explicit content, unless not technically feasible or is prohibited by copyright protection. Schools shall also have available at the school for parent review all instructional materials that include sexually explicit content.

Schools shall defer to parents to determine whether the use of sexually explicit content in instructional materials, if any, is appropriate for their child. This will be done through an opt-out questionnaire on Parentvue or in writing. Refusal to complete the Parentvue questionnaire or submit opt-out in writing will be considered consent to access sexually explicit material.

Upon a parent's request, schools shall provide, in a manner that is not punitive, alternative instructional materials for the student that do not include sexually explicit content.

Parents may change their decision with respect to the use of alternative instructional materials by providing written notice to the school.

SELECTION AND REVIEW OF INSTRUCTIONAL MATERIALS

Critical to the development of curriculum is the selection of instructional materials, including library resources and textbooks. Text, media, and other aids must enhance the achievement of those specific goals, objectives, and strategies which that have been identified and stated. Therefore, the selection or exclusion of materials in the classroom or library should also be procedurally and substantively consistent with the policies of the School Board.

The selection of instructional materials has generally been the prerogative of the Board, with the exception of those items related to sex education and religious/moral education (Board of Education, Bylaws and Regulations). The State Board of Education provides that the selection of all instructional materials is the responsibility of the local Board. The state adopts basal textbooks in the subject areas specified by the Board of Education (Virginia Constitution, Article VIII, Section 5).

The State Board of Education places with local School Boards the responsibility for the selection, approval and utilization of instructional materials. In the selection of instructional materials, the local School Board is responsible for the following:

- 1. developing local criteria for selection.
- 2. approving materials which are consistent with instructional goals and objectives.

Principles for Selection of Instructional Materials and Procedures for Reconsideration of Challenged Materials

A. Statement of Principle

Instructional materials should support and enrich the curriculum by stimulating growth of factual knowledge, literary appreciation, aesthetic values and ethical standards. Instructional materials also provide background information for the development of opinions and informed judgments.

B. Responsibility for Selection

The Spotsylvania County School Board is legally responsible for all matters relating to the operation of the Spotsylvania County Public Schools. The responsibility for the selection of educational materials is delegated to professional instructional personnel employed by the Board.

C. Personnel Responsible for Selection

The sSelection of instructional materials is a continuous process which that involves principals, supervisors, faculty, parents, and students. The responsibility for coordinating the selection process rests with the professional personnel, in accordance with the following criteria and procedures.

D. Criteria for Selection

- 1. The process for evaluating materials is continuous and systematic. It is preferable to examine materials before purchasing them; however, this is sometimes impractical, such as with library books. In such cases, selection is based upon bibliographic reference sources, selected lists, and reviews in reputable professional journals and publications.
- 2. First consideration is given to the needs of the individual school based on knowledge of the curriculum, of the existing materials, and of the needs of children and youth. Requests from users of the materials (administrators, department chairpersons and/or grade-level leaders, faculty, parents, and students) are given high priority. Materials are selected to provide for variations in readability and levels of comprehension.
- 3. Materials for purchase are considered on the basis of:
 - a. overall purpose.
 - b. timeliness.
 - c. authoritativeness.
 - d. format and cost.
 - e. objectivity.
 - f. appropriateness to the level of instruction, age level, etc.
 - g. importance of the subject matter to student interests and curriculum needs.
 - h. quality of writing or production.
 - I. readability and popular appeal.
 - j. reputation of the author, artist or producer.
 - k. accuracy and scope of coverage.
 - I. representation of differing points of view on controversial subjects.
 - m. potential use.

E. Gifts

Gifts of materials or of funds with which to purchase materials are accepted with the understanding that their use or disposition will be determined by those persons having the responsibility for acquisitions, according to the same selection criteria and procedures as purchased materials.

F. Procedures for Selection of Instructional Materials

- 1. In selecting materials for purchase, personnel shall evaluate the existing materials, assess curricula needs and consult where appropriate:
 - a. reputable, unbiased, professionally prepared selection aids.
 - b. department chairpersons and/or grade level representatives.
 - c. staff personnel, students, parents, library media personnel, etc.
 - d. bibliographies and suggested materials listed in textbooks.

- 2. In determining materials to be purchased for the school media center, personnel shall follow these procedures:
 - a. Multiple items of outstanding and frequently used materials are purchased as needed.
 - b. Worn and missing basic items are replaced periodically.
 - c. Out-of-date or no longer useful materials are withdrawn from the collection and replaced by new and appropriate materials.
 - d. Audio-visual materials believed to be desirable for which reviews are not available are requested for preview.

G. Reconsideration of Challenged Instructional Materials

Despite the care taken to select appropriate and valuable materials, occasional objections to a selection are made. Persons requesting permission to examine instructional materials may examine such materials in a way so as not to disrupt the normal operations of the school. Requests for reconsideration of challenged instructional materials will be handled one at a time in the order received but will alternate between individual challengers, in the event more than one individual requests reconsideration of materials.

If a complaint is made, the procedures are as follows:

- 1. School personnel listen to the complaint, make no commitment, advise the complainant to arrange a conference with the principal, and notify the principal of the complaint.
- 2. It is the complainant's responsibility to arrange a conference with the principal.
- 3. At this conference, the principal invites the complainant to file his objections in writing on the form "Request for Reconsideration of Instructional Materials."
- 4. A complainant who does not complete and return the form receives no further consideration.
- 5. Upon receipt of the completed form, the principal will render a decision or requests a review of the challenged material by an ad hoc school review committee consisting of no less than three people (a teacher, a parent, and a concerned citizen), within fifteen (15) twenty-eight (28) working days, and notifies the superintendent or designee that such review is being done.
- 6. The principal or school review committee takes the following steps after receiving the challenged materials:
 - a. reads, rReviews, views or listens to the material in its entirety;
 - checks for sexually explicit content as defined in Virginia Code Section 22.1-16.8 and 2.2-2827, meaning (i) any description or (ii) any picture, photograph, drawing, motion picture film, digital image or similar visual representation depicting sexual bestiality, a lewd exhibition of nudity, as nudity is defined in Virginia Code Section 18.2-390, sexual excitement, sexual conduct, or sadomasochistic abuse, as also defined in Section 18.2-390, coprophilia, urophilia, or fetishism.

The following definitions from Virginia Code Section 18.2-390 apply:

- i. Nudity means a state of undress so as to expose the human male or female genitals in a discernibly turgid state.
- ii. Sexual conduct means actual or explicitly simulated acts of masturbation, heterosexuality, homosexuality, sexual intercourse, or physical contact in an act of apparent sexual stimulation or gratification with a person; clothed or unclothed genitals, pubic area, buttocks, or if such be female, breast.
- iii. Sexual excitement means the condition of human male or female genitals when in a state of sexual stimulation or arousal.
- iv. Sadomasochistic means actual or explicitly simulated flagellation or torture by or upon a person who is nude or clad in undergarments, a mask or bizarre costume, or the condition of being fettered, bound, or otherwise physically restrained on the part of one so clothed.
- c. **d**Determines the extent to which the material supports the curriculum;
- d. **Completes the appropriate "Checklist for School Review Committee's Reconsideration of Instructional Materials," judging the material for its strength and value as a whole and not in part; and,**
- e. **s**Submits the review checklist to the principal within the fifteen (15) twentyeight day deadline.
- 7. Upon receipt of the checklist, the principal makes a decision as to the action to be taken removal, retention; or retention with content warning, making it available only to students whose parents have not opted their children out of accessing sexually explicit materials and notifies the complainant and the superintendent or designee in writing. Copies of the completed "Checklist for School Review Committee's Reconsideration of Instructional Materials" and the complainant's completed request for material reconsideration are to be forwarded to the superintendent also.
- 8. Should the complainant not be in agreement with the principal's decision, he or she may formally request further consideration by the superintendent and the Board.
- 9. The superintendent, upon meeting with the complainant, provides direction as to a further course of action.
- 10. Should it be necessary, the Board is responsible for rendering a final disposition relative to the challenged material.
- 11. During the time of reconsideration, the continued usage of the challenged material is left to the discretion of the principal.
