Education

1. **The Americanism Enforcement Act:** The bill stipulates consequences for teachers and school administrators who refuse to teach Americanism. [Texas H.B. 4509 - <https://capitol.texas.gov/tlodocs/87R/billtext/html/HB04509F.htm>]
2. **The Reading, Writing and Arithmetic Act:** The bill would require school boards to adopt policies which prioritize the basics of reading, writing, and arithmetic over other subjects. <https://www.cde.state.co.us/coloradoliteracy/readactstatuteandstateboardrules>.
3. **The My Student, My Choice Act:** The bill funds students rather than schools, allowing for parents to choose where to send their students to school, including private or public. [Nebraska's LB939 (2024). https://nebraskalegislature.gov/bills/view_bill.php?DocumentID=55201&docnum=LB939&leg=108]
4. **The Kentucky CRT Bill:** The bill prohibits the teaching of critical race theory in public schools. [Kentucky S.B. 138 - <https://apps.legislature.ky.gov/record/22rs/sb138.html>]

7. **The Founding Documents Act:** The bill would require public school libraries to keep and make available to students copies of the founding documents of the United States and of Nebraska. [South Carolina H.B. 3002 - https://www.scstatehouse.gov/sess124_2021-2022/bills/3002.htm]
8. **The Teacher Liability Insurance Act:** The bill would mandate that school administrators inform teachers about the choices of vendors for liability insurance. [On the Table]. — *Murphy*
9. **Eliminate Media Literacy and Digital Citizenship Classes Act:** The bill would prohibit school districts from funding media literacy and digital citizenship classes or any other type of class which is designed to indoctrinate students into Left-wing ideology. Amy Klobuchar (D-MN) are actively promoting media literacy and digital citizenship in schools, which trains students how to filter the media for Left-wing truth. 22. **Stand Your Ground:** The bill would protect homeowners in the event that they kill or injure as an act of self-defense in protection of their home or property. [NE LB1269 (2024)]

25. **The Free Speech Protection Act:** The bill would further protect the right to free speech by prohibiting corporations from infringing on the free speech rights of their employees, customers, and users of their products. 26. **The Anti-Surveillance and Government Spying Act:** The bill would prohibit the State of Nebraska, Law Enforcement, and political subdivisions from using mass surveillance technology, such as remotely activating the microphones in cell-phones, to spy on the citizens of Nebraska without a warrant. 29. **The Child Welfare Maximization Act:** The bill prohibits governmental entities from discriminating against child welfare workers on the basis of their religious beliefs. [On the Table]

31. **The Marriage Diversity Act:** The bill protects those who define marriage as the union between one man and one woman as a matter of free speech embedded in the First Amendment. [On the Table]

34. **The Florida Individual Freedom Bill:** The bill protects individual freedoms in the workplace, making it unlawful to compel a person to hold certain beliefs as a condition for employment, membership, certification, etc. Florida S.B. 148 (2022).

43. **Washington State H.B. 1227 (2021-2022):** California Assembly woman, Celeste Rodriguez, introduced A.B. 495 in 2025, a bill that that would allow virtually anyone to take custody A child! 44. **The Adoptive Parental Rights Act:** Jessica Bates of Oregon recently had her adoption application denied by the Oregon Department of Human Services because she refused to agree to "respect, accept, and support" the self-identified gender identity and sexual identity of her adopted child. The 9th Circuit Court of Appeals overturned the lower courts decision and decided that the State of Oregon had violated her rights as a parent. Legislation is needed to prevent this from ever happening in Nebraska. <https://www.christianpost.com/news/oregon-cant-stop-christian-mom-from-adopting-appeals-court.html>. NSS 43-101 allows for same sex couples to adopt children. 51. **Wisconsin Citizenship Voting Requirement:** In 2024 voters in Wisconsin voted successfully to amend the Wisconsin State Constitution with language permitting only U.S. Citizens age 18 and older to vote in federal, state, local, and school elections.

52. **Iowa Amendment 1 (2024):** This was a constitutional amendment passed by the voters in 2024 which clarified that only U.S. citizens could vote in elections by changing the word 'every' to the word 'only'. This is important because the Nebraska State Constitution uses the word 'each' instead of the word 'only'. The Iowa ballot initiative allows those who are 17 years old to vote in primary elections provided that they turn 18 before the general election.
