Count I

COMES NOW Andrew D. Olson, as Prosecuting Attorney of Cerro Gordo County, Iowa, and in the name and by the authority of the State of Iowa, accuses JUSTIN CARTER GILMORE of the crime of: **Criminal Gang Participation**, committed as follows:

The said **Justin Carter Gilmore**, on or about the month of November 2018, in the County of Cerro Gordo, and State of Iowa, did actively participate in or was a member of a criminal street gang and did willfully aid and abet any criminal act committed for the benefit of, at the direction of, or in association with any criminal street gang, all in violation of Sections 723A.2, a Class D Felony.

Count II

COMES NOW Andrew D. Olson, as Prosecuting Attorney of Cerro Gordo County, Iowa, and in the name and by the authority of the State of Iowa, accuses JUSTIN CARTER GILMORE of the crime of: **Gang Recruitment**, committed as follows:

The said **Justin Carter Gilmore**, on or about the month of November 2018, in the County of Cerro Gordo, and State of Iowa, did solicit, recruit, entice, or intimidate a minor to join a criminal street gang, all in violation of Sections 723A.3(1), a Class C Felony.

Count III

COMES NOW Andrew D. Olson, as Prosecuting Attorney of Cerro Gordo County, Iowa, and in the name and by the authority of the State of Iowa, accuses JUSTIN CARTER GILMORE of the crime of: **Provide Support for Terrorism**, committed as follows:

The said **Justin Carter Gilmore**, on or about the month of November 2018, in the County of Cerro Gordo, and State of Iowa, did provide material support or resources to a person who commits or attempts to commit terrorism, all in violation of Sections 708A.4(2) and 708A.1, a Class C Felony.

Count IV

COMES NOW Andrew D. Olson, as Prosecuting Attorney of Cerro Gordo County, Iowa, and in the name and by the authority of the State of Iowa, accuses JUSTIN CARTER GILMORE of the crime of: **Conspiracy to Commit Non-Forcible Felony**, committed as follows:


The said **Justin Carter Gilmore**, on or about the month of November 2018, in the County of Cerro Gordo, and State of Iowa, did, with the intent to promote or facilitate the commission of a crime which is an aggravated misdemeanor or felony, one or both of the

following:

- a) Agrees with another that they or one or more of them will engage in conduct constituting the crime or an attempt or solicitation to commit the crime, or,
- b) Agrees to aid another in the planning or commission of the crime or of an attempt or solicitation to commit the crime,

And at least one conspirator committed an overt act evidencing a design to accomplish the purpose of the conspiracy by criminal means, all in violation of Sections 706.1(a) and 706.3(2), a Class D Felony.
