County Supervisors' Decision

On Monday, January 8, the Wright County Board of Supervisors met and held a public hearing regarding a proposal on whether or not to give \$1.5 million in TIFF tax dollars to Eagle Grove schools. The meeting ran from 9:00 to 11:00 on largely the one single topic. Several Eagle Grove residents spoke in favor of the proposal. A number of people spoke against it, including an articulate are erudite speech by our own Gary Berkland.

In the end, the Board closed the hearing, immediately voted without discussion, and approved the initial proposal. For those of us in attendance, it left us feeling (correctly or incorrectly) that the decision was made prior to the meeting, and the public hearing was a pretense.

Gifts for the Kids



On a Personal Note . . .

By ignoring their constituents and the concerns, the County Board of Supervisors disrespected us. This was flat-out wrong. Certainly they have a right to their decision. But law requires a public hearing for a reason, and they made it a sham. I would like to suggest there are some lessons we can learn from the mistakes made by the County Supervisors.

First, we need to always be responsive to our public. Our school is a public institution. Ultimately, they are paying the bills and are due our respect.

Second, we need to treat our students and parents as customers. In business, customers come first. Gone are the days when the public school was the only educational option in a community. Open enrollment first opened the doors back in the 1980's. Now there are charter schools. Iowa's community colleges are now in the business of secondary education. There are free distance learning opportunities like the Iowa Virtual Academy. Also, there are the free online charter schools like Iowa Connections Academy. Customers who do not get the service they feel they deserve may go elsewhere.

Finally, we need to treat each other with respect. All our employees have earned our respect by virtue of serving as civil servants in this public school system. We all, myself included, must treat everyone in our school with respect, courtesy, and professionalism, regardless of our

personal opinions. Respect begins at home. We cannot expect others to respect us if we do not respect ourselves.

During the hearing on Monday, the Supervisors would have looked better if they had discussed the issues, acknowledging that there were valid arguments against the proposal, but explaining why the arguments in favor were more significant requiring them to respond with a vote in favor. That would have shown their respect for us. And they owed us that.
