the defendant committed the crime charged: On November 6, 2018, I, Deputy Andy Grunhovd, went to Barbara Kavars residence for an animal welfare call. Upon arrival I found Kavars dragging a tarp and found a dog, Yeager, an old male Samoyed, lying inside it. Yeager had severe wounds to his hind end and was barely moving, he was packed with feces and mud. I helped Kavars load Yeager into her vehicle. Kavars stated that this happened earlier this morning. Upon exam, Yeager was found to be very thin and severely injured. Yeager died at the veterinarian's office.


