The Department of Ecology has filed an adjudication of the surface and ground waters of Water Resource Inventory Area 1 (WRIA 1), in certain areas of Whatcom and Skagit Counties, Washington, under RCW 90.03 and 90.44. See Statement of Facts with Map, filed on May 1, 2024.

Ecology has identified parties who may claim the right to use of said water. Whatcom County Superior Court Judge David Freeman, has directed summons to be issued and served on all persons claiming the right to divert, withdraw, or otherwise make use of the surface and ground waters of WRIA 1.

YOU ARE NOTIFIED that the purpose of this lawsuit is to determine the rights of all persons to divert, withdraw, or otherwise make use of the surface or ground waters of WRIA 1. **You are directed to complete and file the Court Claim Form with the Whatcom County Superior Court Clerk. A copy of the Court Claim Form is available at Ecology's Bellingham Field Office at 913 Squaticum Way #101, Bellingham, Washington or available at the following internet address, <https://go.ecology.wa.gov/nook-sack-courtclaimform>.**

The deadline to file the Court Claim Form is June 1, 2027. If you fail to file a claim, judgment will be entered determining your right to the use of WRIA 1 water according to the evidence presented to the Court.

Signed and attested by the Whatcom County Clerk pursuant to RCW 90.03.120(2).

To streamline the notification process, the Whatcom County Superior Court has adopted new rules for communicating court hearings, orders, deadlines, and motions in the WRIA 1 adjudication water case.

Updates and legal notices are posted by the court in the docket sheet rather than sent via mail.

The docket sheet

- Is your legal notice of court activity.
- Lists all documents filed in the case.
- Will be updated on the 7th day of each month.
- Can be found along with corresponding documents at <https://whatcomcounty.us/docket> or in person at the Superior Court Clerk's Office at 311 Grand Avenue, Suite 301, Bellingham, WA.
- It is your responsibility to check the docket sheet to stay informed of court activity.
