**Contract and Agreement**

**This contract made and entered into this the 1<sup>st</sup> day of September 2012 by and between Family Attractions Amusements party of the first and Greene Co Fair party of the second.**

**Witnesseth: That for a consideration of the sum of one dollar in hand paid each other, the receipt of which is herein acknowledged and other good and valuable consideration hereinafter set forth, both parties aforesaid bind themselves as follow.**

**That party of the first part agree to present a company consisting of riding devices ,concession stands, and electrical power generators at the approved carnival site of the city of Greenville Tennessee for a period of 6 days and nights.**

**Party of the second part shall furnish security, dumpster, restrooms, water and hard or paved lot. All items must be suitable for midway agreed to accommodate agreed location set forth in paragraph 3, and or number of expected attendance. All items must be preapproved with party of the first.**

**Party of the first will furnish roll tickets, armbands, book tickets, and ticket sellers at no charge to party of the second. Family Attractions will furnish a minimum of 25 rides**

**Party of the second agrees to publicize the event thru their regular advertising schedule and with such additional coverage as they deem necessary, at their own expense.**

**Party of the first will provide party of the second banners and posters each year for additional advertising tools.**

**Party of the first will keep the area used by them clean and shall leave same area cleaned and in the same condition as they found it.**

**Party of the first will pay party of the second:**

**30% of ride gross up to \$100,000**

**32.5% from 100,001 to 125,000**

**35% anything over \$125,000**

**City electric for RV trailers**

**\$100 for each game or food concession**

**Party of the second part agrees that they will not permit other carnival company to exhibit on the carnival site for a period of 60 days.**

That is mutually agreed by both parties hereto that there is no other contract or promise either written or verbal, existing between them, and that this contract is subject to approval of Family Attractions Amusement Company LLC either by wire or by letter.

Page 2

Party of the first agrees to furnish a certificate of insurance showing evidence of protection to the party of the second part.

In case of accident or delay, strike, fire, cyclone, epidemic or any unforeseen occurrence over which party of the first part or party of the second has no control, neither party will be held liable for damages. Party of the first part holds the right to reassign or cancel this contract with a written notice.
