TERMS & CONDITIONS

- I reside/conduct business within Pima County at the address identified on the application.
- I currently own and/or operate working gasoline-powered lawn and garden equipment in Pima County.
- Lawn Mower Voucher Residents: Limit one (1) voucher per gasoline powered lawn mower relinquished per address every three (3) years. Voucher may only be used for an electric or battery powered lawn mower.
- Lawn & Garden Devices Residents: Limit five (5) lawn and garden device vouchers per address every three (3) years, one
  per gasoline powered device type relinquished (chain saw, hedge trimmer, string trimmer, edger, leaf blower/vacuum, tiller, leaf
  shredder, cutter or pole saw). Voucher must be used towards the purchase of an electric, battery or manual lawn and garden
  device or tool(s) as listed on the Pima County Department of Environmental Quality website.
- Commercial Businesses: Limit one (1) voucher per gasoline powered lawn mower relinquished. Lawn mower voucher may only be used for an electric or battery powered lawn mower. Limit one (1) voucher per gasoline powered lawn and garden device relinquished. Device voucher must be used towards the purchase of an electric, battery or manual lawn and garden device or tool (s) as listed on the Pima County Department of Environmental Quality website.
- I will deliver and relinquish working gasoline powered lawn and garden equipment to a designated Lawn & Garden Equipment Drop-Off Location in Pima County.
- I understand vouchers may only be used in-store at designated Home Depot locations in Pima County. On-line orders from HomeDepot.com must be made with a Service Desk Associate in-store.
- Multiple vouchers may not be combined for a single purchase transaction.
- I am responsible for payment greater than the voucher amount.
- Unused voucher value will be forfeited and cannot be used in another transaction.
- Pima County Department of Environmental Quality reserves the right to adjust limits on the number of pieces of equipment
  accepted and vouchers distributed as dictated by funding availability and to provide fair opportunity for community members.
- · Failure to comply with the program Terms & Conditions may result in disqualification of the program and legal action.
- I understand there is an expiration date for turning in the gasoline powered equipment once I am issued a Drop-Off Verification Form. If I am unable to comply with this time restriction, it is up to me to contact Pima County Department of Environmental Quality to request an extension that may or may not be able to be granted.
- I understand that vouchers have an expiration date and that Home Depot cannot honor a voucher after the expiration date. If I
  have not used my voucher by the expiration date, it is up to me to contact Pima County Department of Environmental Quality for a
  new voucher. I know that my gasoline powered equipment cannot be returned whether I use the voucher or not.

Activity Permits: A copy of the permit will be emailed to the applicant within the hour. (If created after 11PM, permits will be emailed after 5AM.) Please print your record and retain a copy for your records.

Lawn & Garden Vouchers: Your application has been received and will be reviewed. If everything is in order, you will receive an email with the form you will need to take with the device when you turn it in.
