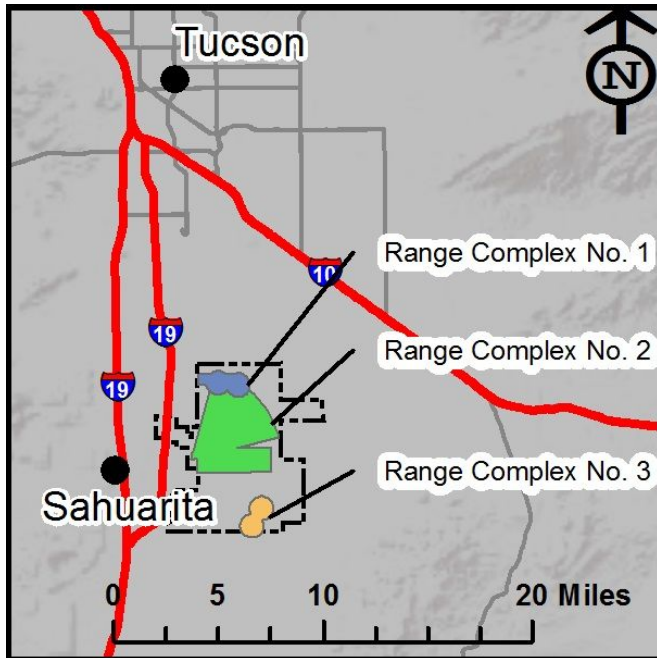

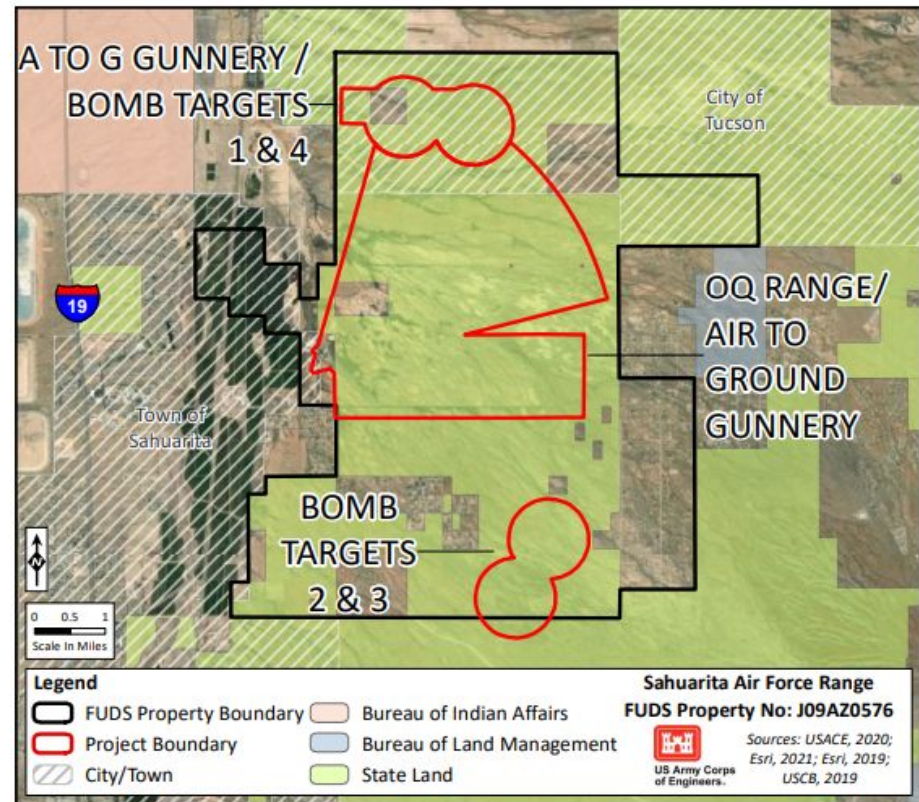
Site Background

- The former Sahuarita Air Force Range (**SAFR**) is a Formerly Used Defense Site (**FUDS**) located near Sahuarita, AZ. It was established as a pattern bombing range in support of Davis-Monthan Air Force Base.
- The former SAFR (Site) was used by the U.S. military for gunnery and bombing ranges from about 1942 to 1958.

Site Background (cont.)



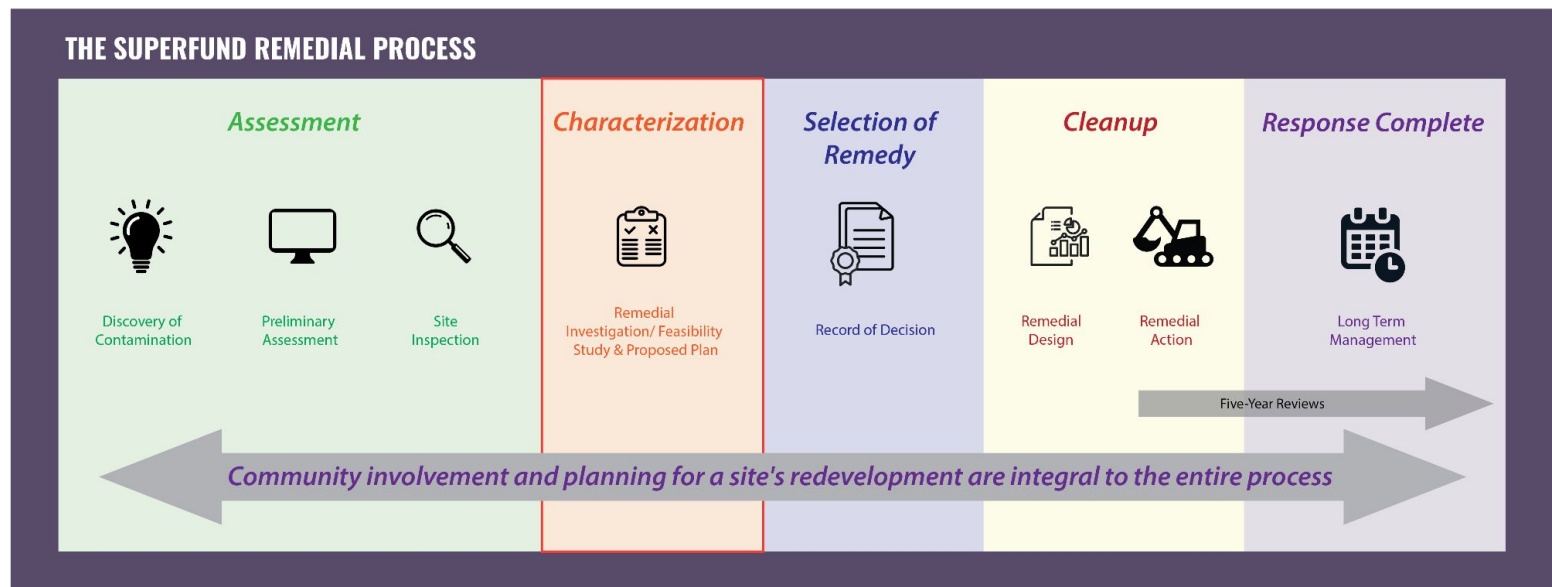
Map of Sahuarita Air Force Range



Site Status

The U.S. Army Corps of Engineers (**USACE**) is conducting an environmental investigation and accompanying study to evaluate Site cleanup options - USACE is in the “Characterization” phase.

Site Risk to the Community

Weapons debris found at the Site over the years has included practice bombs, high explosive incendiary projectiles, small arms and other related items.



Site Risk to the Community

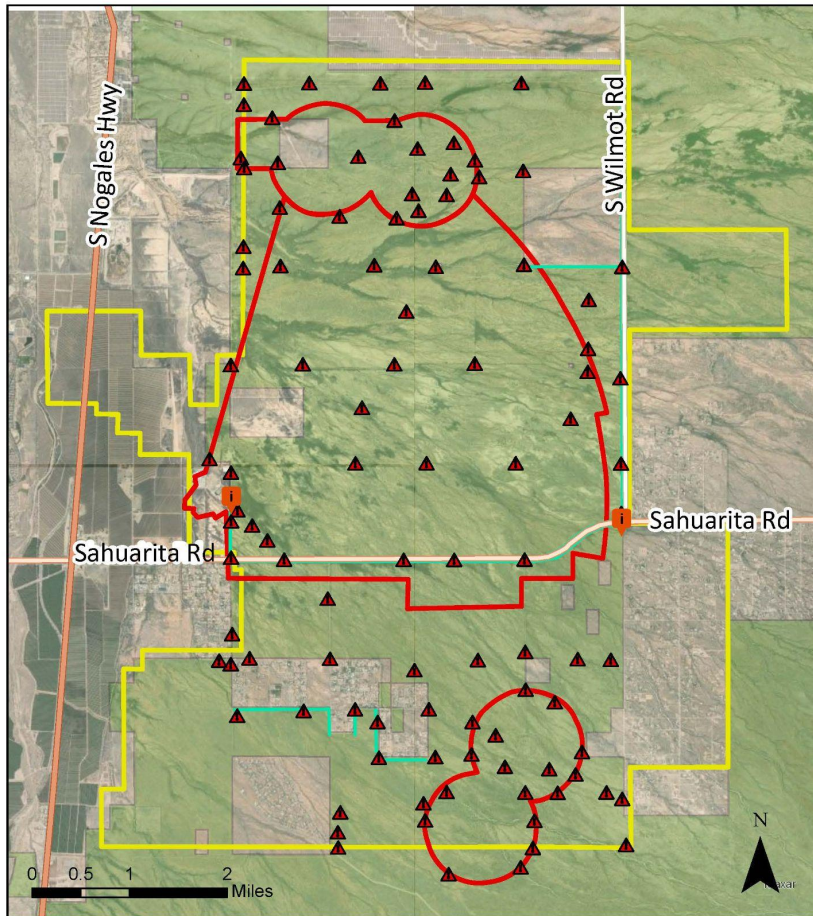
Because USACE has not completed its investigation and cleanup, similar weapons debris may be present in the area of the Site and poses a risk to the public.

State of Arizona Action

Out of an abundance of caution, the State of Arizona is taking action to inform and warn the community about this risk by installing warning signs and information kiosks on Arizona State Trust Land in the area of the Site.

- This is an interim measure to provide hazard warnings while USACE completes its investigation and develops plans for the Site cleanup - USACE supports the State of Arizona in taking this action.
- State-contracted, professionally certified unexploded ordnance specialists will be onsite to oversee the work.

- 100 warning signs will be installed in the ground or attached to existing fencing and structures.
- Two information kiosks containing additional information about the Site and how to identify possibly harmful debris and report the discovery of those items to the proper authority will be constructed.

USACE Guidance for the Site



- Recognize – when you may have encountered a munition and that munitions are dangerous.
- Retreat – do not approach, touch, move or disturb it, but carefully leave the area.
- Report – call 911 and advise police of what you saw and where you saw it.
