ON 6-26-2025 AT APPROXIMATELY 1100 HOURS RICHARD KELM WAS PLACED UNDER ARREST AT [REDACTED] MCCULLOCH BLVD N AT THE LAKE HAVASU CITY POLICE DEPARTMENT FOR POSSESSION OF DANGEROUS DRUGS X 5, POSSESSION OF DANGEROUS DRUGS TO TRANSFER, POSSESSION OF A NARCOTIC DRUG, POSSESSION OF DRUG PARAPERNALIA, PANDERING, AND FRAUDULENT SCHEMES AND PRACTICES.

ON 6-24-2025 AT APPROXIMATELY 1650 HOURS [REDACTED] REPORTED RICHARD KELM HAD HIRED HER AND HER FRIEND [REDACTED] AS A PROSTITUTED PERSON IN WHICH THEY ENGAGED IN SEXUAL ACTS FOR MONEY AND ILLEGAL DRUGS AT [REDACTED] SWORDFISH DR.

ON 6-24-2025 AT APPROXIMATELY 1310 HOURS OFFICER MADDEN ARRESTED [REDACTED] FOR A DRUG OFFENSE NOT RELATED TO THIS INVESTIGATION. DURING HIS INVESTIGATION OFFICER MADDEN HAD SEEN [REDACTED] WAS A SUSPECT IN THEFT OF FIREARMS, CASH AND CREDIT CARDS REFERENCE DR# [REDACTED]. THE VICTIM [REDACTED] IN THE THEFT CASE ALLEGED HE HAD CONSENSUAL SEX WITH BOTH [REDACTED] AND [REDACTED] ON 5-27-2025 AND 06-07-2025 IN WHICH THE ITEMS WERE STOLEN.

[REDACTED] AGREED TO SPEAK TO OFFICER MADDEN REFERENCE THE THEFT CASE AFTER HE READ HER MIRANDA. DURING THE INTERVIEW, [REDACTED] DISCLOSED [REDACTED] HAD INTRODUCED RICHARD KELM TO HER. THEY HUNG OUT AT A CONCERT IN VEGAS APPROXIMATELY 3 TO 4 MONTHS AGO IN WHICH RICHARD SUPPLIED THEM WITH DRUGS. RICHARD PROVIDED [REDACTED] A W-2 FORM TO PLACE HER AS A PERSONAL ASSISTANT TO HIS COMPANY "KELM CONSTRUCTION INC" WORKING AT HIS HOME ADDRESS LISTED AS [REDACTED] SWORDFISH DR. [REDACTED] STATED RICHARD SET HER UP TO DO "PROSTITUTION" UNDER THE GUISE THAT HE WAS PAYING HER AS AN ASSISTANT TO HIS PRIVATE COMPANY, KELM CONSTRUCTION INC.

INITIALLY [REDACTED] WAS NOT FORTHCOMING WITH INFORMATION AND CITED SHE WAS HOMELESS AND A DRUG ADDICT AND SHE WAS EMBARRASSED TO TELL OFFICER MADDEN SHE WAS HAVING SEX WITH AN OLD MAN. [REDACTED] STATED "YEA I MEAN, IT'S, HE LITERALLY SET ME UP TO DO PROSTITUTION. HE GOT ME ON HIS W-4'S OR WHATEVER FOR PROSTITUTIE, LIKE TO BE HIS HAND MAID."

RICHARD ALSO HAD [REDACTED] FILL OUT TAX PAPERWORK BUT [REDACTED] DID NOT FINISH THE APPLICATION. BOTH HER AND [REDACTED] ENGAGED IN SEXUAL ACTS AT HIS RESIDENCE IN WHICH [REDACTED] DESCRIBED RICHARD'S PENIS IN HER VAGINA. [REDACTED] STATED SHE HAS NEVER PERFORMED ANY JOB PERFORMANCES AS A PERSONAL ASSISTANT FOR HIS BUISNESS OTHER THAN ENGAGING IN SEXUAL ACTS. RICHARD TOLD [REDACTED] IN ORDER FOR HER TO BE PAID SHE HAD TO COME OVER TWICE A WEEK. SHE HAS BEEN TO HIS RESIDENCE TWICE WHERE RICHARD HAD GIVEN HER XANAX, "MOLLY" (SLANG FOR MDMA) AND COCAINE. RICHARD HAD RECORDED THEM HAVING SEX WHICH SHE BELIEVED TO BE ON A CELL PHONE. SHE MAY HAVE HAD SEX WITH RICHARD ANOTHER TIME BUT CANNOT REMEMBER BECAUSE HE PROVIDED HER XANAX AND SHE BLACKED OUT AND WOKE UP NAKED IN HIS BED. ACCORDING TO [REDACTED] SHE WANTED TO USE DRUGS SO SHE DID NOT HAVE TO REMEMBER WHAT SHE WAS GOING TO DO. [REDACTED] FURTHER EXPLAINED THERE WAS A RULE WHERE YOU TAKE A FULL XANAX WHEN YOU WALK INTO HIS HOUSE AND CAN TAKE A HALF IN BETWEEN. BEFORE YOU LEAVE HIS HOUSE YOU CAN TAKE ANOTHER FULL XANAX. SHE OBSERVED HIM PULLING OUT THE DRUGS FROM HIS DRAWER.

█████ EXPRESSED SHE DOES NOT WANT TO HAVE SEX WITH RICHARD FOR MONEY OR DRUGS BUT SHE IS CURRENTLY HOMELESS AND STRUGGLING WITH HER DRUG ADDICTION. SHE RECALLS RICHARD KEEPING HIS DRUGS IN A GRAY AND BLUE CAMO STYLE BACK PACK. SHE RECALLS RICHARD HAVING THE DRUGS ON THE TABLES LOCATED ON BOTH SIDES OF HIS BED. RICHARD ISSUED HER A CHECK IN THE AMOUNT OF \$774.50 WHICH WAS PAYMENT FOR HER HAVING SEX WITH HIM. SHE WAS TO PROVIDE █████ A PORTION OF THE FUNDS BUT ONLY MADE THE CHECK OUT TO █████ AS █████ DID NOT FINISH FILLING OUT HER W-2 FORM FOR HIS BUSINESS.

█████ STATED SHE HAD A THREAD OF MESSAGES BETWEEN HER AND RICHARD SHE WOULD WILLINGLY PROVIDE TO SHOW RICHARD REQUESTING HER TO GO TO HIS HOUSE AND HER SENDING HIM NUDE VIDEOS VIA HIS INSTAGRAM HANDLE. SHE ALSO HAD MESSAGES LOCATED ON HER IPAD BETWEEN HER AND RICHARD.

█████ ALSO STATED SHE JUST TURNED 18 AND SHE WAS UNSURE IF IT WAS A W-2 FORM OR A W-4 FORM SHE HAD FILLED OUT.

NOTE: OFFICER MADDEN INFORMED DETECTIVES OF █████ STATEMENTS OF BEING PROSTITUTED AND RECEIVING DRUGS.

A VIDEO RECORDING WAS TAKEN OF THE MESSAGES DUE TO THEM SPANING THROUGH SEVERAL DAYS OF CONVERSATION. A COPY OF THE RECORDING WAS UPLOADED TO AXON EVIDENCE.COM.

THE FOLLOWING WERE SIGNIFICANT MESSAGES NOTED THAT CORROBRATED [REDACTED] STATEMENTS:

JUNE 9TH- RICHARD TOLD [REDACTED] HE WAS GOING TO GIVE HER A CHECK FOR DOUBLE THE AMOUNT TO SPLIT WITH [REDACTED] BECAUSE SHE DID NOT TURN IN HER PAPERWORK. RICHARD TOLD HER [REDACTED] WAS TO GET \$500.00 AND [REDACTED] \$500.00 BUT AFTER TAXES IT WOULD ABOUT \$450.00 EACH.

NOTE: BETWEEN JUNE 10TH AND 13TH THERE WERE MESSAGES ATTEMPTING TO ARRANGE TIMES FOR [REDACTED] TO GET IN HER 2 DAYS WHICH WERE IN THE LATE EVENING HOURS.

JUNE 13TH AT 12:39 PM HOURS, RICHARD TOLD [REDACTED] TO LET HIM KNOW WHEN SHE WAS OFF DUE TO HER ONLY HAVING THAT NIGHT AND SUNDAY FOR HER TO GET HER 2 DAYS IN. [REDACTED] RESPONDS BY STATING THAT TONIGHT *IK (I KNOW) AND IF HE LETS HER SHE WILL BUY SEXY STUFF BUT IF NOT IT WAS FINE.

JUNE 13TH AT 06:09 PM HOURS - RICHARD RESPONDS STATING "OK. KEEP ME POSTED SEXY STUFF SOUNDS GOOD! WHO WAS THAT FOR?" [REDACTED] RESPONDS LATER APOLOGIZING FOR GOING HOME AND PASSING OUT.

JUNE 13TH AT 10:58PM - RICHARD TELLS [REDACTED] "GUESS YOUR NOT SHOWING UP FOR WORK, SO NO PAYCHECK MONDAY"

JUNE 14TH- [REDACTED] RESPONDS SAYING SHE CANT COME TONIGHT AND CONTINUES TO MESSAGE THAT SHE CAN MAKE IT FUN, IN THE MORNING OR SHE COULD COME BY NOW TO MAKE IT "DIRTY" AND WAKE HIM UP WITH A LITTLE SURPRISE.

JUNE 15TH- [REDACTED] ASKS RICHARD WHAT THEY WERE DOING SO SHE KNEW HOW TO DRESS AND IF THEY WERE GOING TO HANG OUT AT HIS HOUSE.

THE MESSAGES SHOW THE TYPE OF WORK THAT RICHARD WAS EXPECTING FROM [REDACTED] AND THE TIME IN WHICH [REDACTED] WAS REQUESTED TO GO OVER WAS LATE AT NIGHT.

██████ CALLED RICHARD VIA INSTAGRAM.

DURING THE PHONE CALL, RICHARD STATED HE HAD A RECORDING OF ██████ ASKING IF HE HAD VIDEO CAMERAS.

██████ TOLD HIM SHE WAS ASKING ABOUT HIS CAMERAS BECAUSE SHE DID NOT WANT HIS DAUGHTERS WATCHING HER HAVE SEX WITH HIM.

RICHARD TOLD HER THAT HE HAD OTHER RECORDING OF HER BUT DID NOT ELOBRATE WHAT THOSE RECORDINGS WERE.

██████ ASKED RICHARD IF HE COULD GET HER SOME XANAX AND ASKED IF THEY COULD DISCUSS ISSUES.

RICHARD RESPONDED WITH "I CAN YEA".

RICHARD REQUESTED FOR ██████ TO SEND HIM THE ADDRESS SHE WAS AT SO HE COULD SEND AN UBER TO PICK HER UP AS HE COULD NOT PICK HER UP HIMSELF DUE TO HIM DRINKING.

THE ONE PARTY CONSENT CALL WAS RECORDED BY DETECTIVES, WHICH CONFIRMED RICHARD DOES SUPPLY ██████ WITH DRUGS THAT ARE NOT PRESCRIBED TO HER AND HE WOULD PROVIDE THEM ONCE SHE CAME TO HIS RESIDENCE.

THE ONE PARTY CONSENT CALL ALSO CONFIRMED ██████ STATEMENT THAT RICHARD HAD RECORDED HER.

THE ONE PARTY CONSENT CALL WAS RECORDED AND UPLOADED TO EVIDENCE.COM.

A SEARCH WARRANT WAS DRAFTED AS IT WAS BELIEVED RICHARD KELM HAD IN HIS POSSESSION XANAX, A DANGEROUS DRUG AND PRESCRIPTION ONLY MEDICATION FOR THE PURPOSES OF SUPPLYING IT TO ANOTHER INDIVIDUAL AND OTHER DRUGS IN WHICH HE SUPPLIES SUCH AS MOLLY.

RICHARD KELM WAS ALSO BELIEVED TO BE IN POSSESSION OF DIGITAL DATA SHOWING THE RECORDING OF SEXUAL ACTS WITH ██████ AND ██████ WHILE THEY WERE UNDER THE INFLUENCE OF DRUGS.

RICHARD KELM WAS BELIEVED TO HAVE FRAUDULENT DOCUMENTS AND INDICIA OF EMPLOYING ██████ AND ██████ AS ASSISTANTS TO HIS PRIVATE BUSINESS "KELM CONCRETE INC".

JUDGE DUNBAR APPROVED THE SEARCH WARRANT ON 6-25-2025 AT 1910 HOURS.

-RICHARD PICKED UP [REDACTED] AND DROVE HER TO VEGAS THEN SENT [REDACTED] GAS MONEY TO DRIVE UP IN HER PERSONAL VEHICLE.

-RICHARD INSISTED THAT [REDACTED] BROUGHT DRUGS (LATER TESTED FOR MDMA) TO THE HOTEL ROOM IN LAS VEGAS AND SHE LEFT THE REMAINDER OF THE DRUGS BEHIND. RICHARD ADMITS TO TAKING THE DRUGS BACK TO HIS RESIDENCE TO KEEP BECAUSE OF THEIR STREET VALUE.

-RICHARD STATED HE DID NOT HAVE SEX WITH [REDACTED] OR [REDACTED] DURING THIS TIME BUT DID SHOWER WITH [REDACTED]
