Helena Police Department Detective Spencer Snelling affirms that probable cause exists to support filing the charges of **COUNTS I - III – SEXUAL INTERCOURSE WITHOUT CONSENT**, felonies, in violation of Mont. Code Ann. § 45-5-503(1) and (4)(a), and **COUNTS IV – V -SEXUAL ASSAULT**, felony, in violation of Mont. Code Ann. § 45-5-502(1) and (3); alleged to have occurred in Lewis and Clark County, Montana, between on or about January 1, 2017, and on or about July 6, 2017, against the above-named defendant based upon the reports of the Helena Police Department as follows:

On July 20, 2017, eight year olds D. and K. were forensically interviewed by a trained interviewer at the Lewis and Clark County Child Advocacy Center.

D. told the interviewer the defendant rubbed her vagina under her clothing on more than one occasion. D. said this happened in her residence. D. told the interviewer that on at least one occasion, K. was sitting in a chair with D. and the defendant, and D. saw the defendant rub K.'s vagina. D. said sometimes when the defendant rubbed her vagina and it felt good. Other times, she said he rubbed farther down and pushed hard and it hurt. The undersigned knows based on his training and experience that a prepubescent girl will experience significant pain if

1 her cervix is touched and believes the pain described by D. occurred because the defendant
2 penetrated her vagina with his finger. D. told the interviewer on one occasion she was helping
3 the defendant clean a bathroom in her residence when she began scratching her vagina. The
4 defendant then kissed and licked her vaginal area.

5 During K.'s interview, she said the defendant rubbed her vagina while she was sitting in
6 a chair with him and D. K. said on one occasion, the defendant was "in the middle of her
7 front" and his fingernails scratched her and it hurt. On another occasion, K. said she was
8 camping with her family in a camper. She slept with the defendant on a bed that pulled out of a
9 couch. K. said the defendant used his front end to go deep into it. K. described the defendant's
10 front end like a banana or a sausage. K. didn't want to look at it because it probably looked
11 disgusting. K. drew a picture of the defendant and circled the area where a male's penis would
12 be in order to describe his "front end."

13 Both girls' parents confirmed the defendant was a regular visitor to the children's
14 residence. K.'s parents said they had gone on a camping trip with the defendant over Memorial
15 Day weekend 2017.

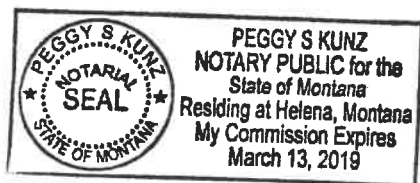
16 The above events took place in Lewis and Clark County, Montana.
