- During the course of the search, a baggy containing a white crystal substance with a presumptive positive for methamphetamine was also located.

- The methamphetamine was located in an unlocked filing cabinet in the bedroom to which the defendant had access.
- When asked, the defendant ultimately admitted to consuming methamphetamine the previous night.
- Considering drug paraphernalia and methamphetamine were located in the defendant's bedroom, I believed there was probable cause to charge him with the above crimes.
