ORDER GRANTING IN PART AND DENYING IN PART PLAINTIFFS'
COMBINED MOTION FOR DECLARATORY JUDGMENT PURSUANT
TO 735 ILCS 5/2-701 AND/OR FOR TEMPORARY (WITH NOTICE) OR
PRELIMINARY INJUNCTION PURSUANT TO 735 ILCS 5/11-101

This cause came to be heard on February 3, 2023, on Plaintiffs' Combined Motion for Declaratory Judgment Pursuant to 735 ILCS 5/2-701 and/or for Temporary (with Notice) or Preliminary Injunction Pursuant to 735 ILCS 5/11-101. Plaintiffs and Defendants JB Pritzker and Kwame Raoul were present through counsel. The Court heard argument and took the matter under advisement.

Plaintiffs' complaint asserts six claims that Public Act 102-1116 violates the Illinois

Constitution in whole or in part. At the hearing, Plaintiffs represented to the Court that, at this
time, they are pursuing only their request for a temporary restraining order on Count IV (equalprotection) and Count V (special legislation) of their complaint. Accordingly, Plaintiffs' motion
is denied with respect to all other requests for relief without prejudice to renewal at an
appropriate time.

The Court finds it is bound by Accuracy Firearms, LLC v. Pritzker, 2023 IL App (5th) 230035, which affirmed the Effingham County circuit court's entry of a temporary restraining order on an equal protection claim materially identical to the one asserted by Plaintiffs in this

action. The Court further finds "special legislation and equal protection challenges are judged by the same standard." *In re Estate of Jolliff*, 199 Ill. 2d 510, 520 (2002). Accordingly, the Court is required by precedent to enter a temporary restraining order on Count IV (equal protection) and Count V (special legislation) of Plaintiffs' complaint.

NOW, THEREFORE, IT IS HEREBY ORDERED:

- 1. A temporary restraining order is entered enjoining Defendants and their officers, agents, employees, and attorneys from enforcing 720 ILCS 5/24-1.9 and 720 ILCS 5/24-1.10 against Plaintiffs Dan Caulkins, Perry Lewin, and Decatur Jewelry & Antiques, Inc. and the members of Plaintiff Law-Abiding Gun Owners of Macon County identified in Exhibit A.
- 2. In all other respects, Plaintiffs' Combined Motion for Declaratory Judgment

 Pursuant to 735 ILCS 5/2-701 and/or for Temporary (with Notice) or Preliminary Injunction

 Pursuant to 735 ILCS 5/11-101 is denied without prejudice.
