A fight over delta-8

CBD shop owners keep selling products state says are illegal

Local shop owners are confused, but keeping delta-8 products on the shelves — even after the state of Texas confirmed the substance remains il-

"We're going to continue to do what feels right to us," Gruene Botanicals owner Sean Timmermann said.

The confusion began after the Texas Department of Health and Human Services posted an online notice clarifying that delta-8 is still illegal in Texas — surprising

many CBD retailers who have been selling the products for months.

Texas House Bill 1325, passed in 2019, makes products with delta-9 tetrahydrocannabinol extract more than .3% of THC illegal.

Delta-8 is legal un-

der the federal Farm Bill passed in 2018 as long as it contains less than .3% of delta-9 THC.

Although delta-8 products from gummies to powder have percentages lower than .3%, the state clarified that any concentration of delta-8 is illegal.

The agency is in the courts after a CBD retailer requested a temporary restraining order from making the substance il-

Another hearing is scheduled for Nov. 5, after a state district judge in Austin denied the request

AREA FORECAST

Big temp changes, chances for rain ahead in forecast

It might be time for that light jacket or fleece sweater and maybe an umbrella.

According to meteorologists at the National Weather Service, a cold front arriving midweek could mean big changes across South Central Texas at the middle to the end of the week.

Forecasters expect fair skies and unseasonably warm temperatures with a high in the lower 80s on Tuesday, but according to NWS Meteorologist Aaron Treadway, a fairly strong arctic cold front and an upper-level disturbance will bring showers and isolated thunderstorms Wednesday through early Thursday along with temperatures turning quite unseasonably cold Thursday through Sat-

"A lot of our October fronts have been more Pacific in origin, so they've cooled us down 10 degrees for a couple of days — this one has a lot colder, more northern, more polar air mass behind it, which is what's going to cool us down more significantly this time around," Treadway

New Braunfels man dies after being hit by train

Police are investigating how a 55-year-old New Braunfels man ended up being struck and killed by an oncoming train early Friday morning, officials

said. David Ferguson, city communications coordinator, said New Braunfels police and fire paramedics were dispatched to the Landa and West Zink Street at 1:27 a.m. Friday after reports of a train-versus-pedestrian incident at the lo-

"A male was struck and killed by a Union Pacific train," Ferguson said.

Precinct 3 Justice of the Peace Mike Rust pronounced the man dead at

Lack of workers squeezing daycares and parents looking for childcare

After many calls, Casandra Ortiz got lucky and got the remaining daycare spot for her granddaughter.

"It was a challenge getting her back in [daycare]," Ortiz said. "Every place I called had a year or months-long waiting list. I

don't even know how First Protestant even had a spot open, it was a miracle."

Like many during the pandemic, Ortiz was working from home. Once schools opened back up, so did daycare slots. But now daycares are full again.

Hansel & Gretel Child Development Center owner Sharon

Wiedenfeld said they "can't get anybody to work."

Brilliant Starts Learning Academy owner and director, Trish Norman, said it is the same for them as well as other daycares.

"We've got a lot of kids, we just don't have staff to get kids in," Norman said. "I've already had four calls this morning trying to get children in, everybody they've called has had the same problem."

Pre-pandemic, child-care workers on average made \$11.65 an hour, according to the biennial 2020 Early Childhood Workforce Index.

The industry is predominantly female and Black, Asian or Latino, with many of those workers experiencing layoffs, furloughs and pay cuts, according to a survey by the National Association for the Education of Young Chil-

Many daycares in New Braunfels are posting job
