Bids received after 2:00 pm will be returned unopened. Bids will be opened and read aloud in the Conference Room at the time specified above. Submit bids for all work as outlined in the bid form. The complete form shall be without alterations, additions, or erasures. All bids must be on a lump sum basis. Bidders shall also submit individual lump sum bids on requested alternates. Work generally includes construction of new tennis courts and outdoor ice rinks at Waconia High School. Specific work consists of removals, excavating, grading, asphaltic pavement, exterior concrete, fencing, tennis nets, posts and wind screen, site restoration and other related work.
