Candidates for federal offices must file between 8:00 a.m., Tuesday, May 22, 2018 and 5:00 p.m., Tuesday, June 5, 2018 in person or by mail with the Office of the Secretary of State, State Office Building, Room 180, 100 Rev. Dr. Martin Luther King Jr. Blvd., St. Paul, MN 55155-1299.

Candidates for state offices must file between 8:00 a.m., Tuesday, May 22, 2018 and 5:00 p.m., Tuesday, June 5, 2018 in person or by mail with the Office of the Secretary of State, State Office Building, Room 180, 100 Rev. Dr. Martin Luther King Jr. Blvd., St. Paul, MN 55155-1299 or with the county auditor of the county in which the candidates resides.

Candidates who will be absent from the state during the filing period may arrange to file during the seven days immediately preceding the candidate's absence from the state. Note: Filing documents may be executed on May 28 although filing offices will be closed for the Memorial Day holiday.
