She reported the recommended levy is \$1,063,382.55 more than the Pay 2018 levy, a 9.08% change in total school property taxes. If property values had remained the same, residents would have seen a slight increase in their school district property taxes. Because the District's total property value increased, the State shifts the funding where more revenue comes from property tax and less comes from State Aid. Plus Xcel who is a major property owner in our boundaries is seeing a large decrease in their property value causing a shift in how the property taxes are spread out which applies to the City, County and School taxes Final approval of the
