Said proposals for the furnishing of all labor and materials for the construction, complete in-place, of the following approximate quantities:

Potential bidders will be required to purchase a current copy of the City General Specifications. Once the current 2018 City General Specifications are purchased, future purchase of project plans and specifications may not require additional purchase of the current 2018 City General Specifications.

Bids will only be accepted from Contractors who purchase digital or paper Bidding Documents as specified above.

No bids will be considered unless sealed and filed with the City of Hanover and accompanied by a cash deposit, cashier's check, or certified check, or bid bond made payable to the City of Hanover for five percent (5%) of the amount bid, to be forfeited as liquidated damages in the event that the bid be accepted and the bidder fail to enter promptly into a written contract and furnish the required bond.

The provisions of Minn. Stat. 16C.285 Responsible Contractor are imposed as a requirement of this contract. All bidders and persons or companies providing a response/submission to the Advertisement for Bids/RFP of the City shall comply with the provisions of the statute.

No bids may be withdrawn for a period of ninety (60) days from the date of opening of bids. The City of Hanover reserves the right to reject any or all bids.
