Sealed Bids for the construction of the 2018 NE Sewer District Improvements will be received by The City of Corcoran, 8200 County Road 116, Corcoran, Minnesota 55340, until 11:00 AM local time on October 2, 2018, at which time the Bids received will be publicly opened and read. The Project consists of utility improvements with the addition of trunk sewer. The bid items shown below are a general representation and estimated quantity of the work included.

Together with removals, traffic control, restoration, and other related appurtenances.

A Pre-bid meeting is scheduled at Corcoran City Hall for 11 AM, Wednesday, September 19th, 2018. Attendance is not required.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis.

Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 am and 5:00 pm and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents also may be examined at the office of the City of Corcoran, City Hall, 8200 County Road 116, Corcoran, MN 55340, on Mondays through Fridays between the hours of 8:00 am and 4:00 pm.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of a deposit of \$50 for each set. Checks for Bidding Documents shall be payable to "Wenck". Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Bidding Documents may also be obtained online by registering with www.questcdn.com, by inputting Quest Project #5895503 on the website's project search page. Following registration, complete sets of Bidding Documents may be downloaded from the Issuing Office's website upon payment of a deposit of \$20. Bid security shall be furnished in accordance with the Instructions to Bidders. The Bid security shall be in the form of a certified check made payable to the "CITY OF CORCORAN" in the amount not less than five percent (5%) of the total bid, or a surety bond in the same amount, running to the OWNER, with the surety company thereon duly authorized to do business in the State of Minnesota. Such Bid Security to be a guarantee that the bidder will not, without the consent of the OWNER, withdraw his bid for a period of ninety (90) days after the opening of bids, and if awarded a contract, will enter into a contract with CITY OF CORCORAN; and the amount of the certified check will be retained or the bond enforced by the OWNER in case the bidder fails to do so. All bid securities except those of the three lowest bidders will be returned within five days after the opening of bids.

Eligible Bidders for this project must meet the Minimum Criteria as defined in the Responsible Contractor Requirement in accordance with Minnesota Statutes § 16C.285, subdivision 3, and additional criteria required by the City of Corcoran.

or

A contractor responding to this solicitation document shall submit to the city a signed statement under oath by an owner or officer verifying compliance with each of the minimum criteria in Minnesota Statutes, section 16C.285, subdivision 3. The term 'responsible contractor' as used in this solicitation document means a contractor as defined in Minnesota Statutes, section 16C.285, subdivision 3. Any prime contractor or subcontractor that does not meet the minimum criteria in Minnesota Statutes, section 16C.285, subdivision 3 or fails to verify that it meets those criteria is not a responsible contractor and is not eligible to be awarded the construction contract for the project or to perform work on the project. A false statement under oath verifying compliance with any of the minimum criteria shall render the prime contractor or subcontractor that makes the false statement ineligible to be awarded a construction contract on the project and may result in termination of a contract awarded to a prime contractor or subcontractor that submits a false statement. A prime contractor shall submit to the city upon request copies of the signed verifications of compliance from all subcontractors of any tier pursuant to Minnesota Statutes, section 16C.285, subdivision 3, clause 7. Refer to the contract documents for additional requirements associated with the Responsible Contractor Law.

Bid Proposals shall be submitted on forms furnished for that purpose. Bids shall be submitted in sealed envelopes clearly inscribed on the outside: "Bid Proposal for 2018 NE Sewer District Improvements, City of Corcoran." No bidder shall withdraw his bid, without the consent of the OWNER, for a period of ninety (90) days after the date for the opening thereof. The OWNER, however, reserves the right to reject any or all bids and to waive any minor irregularities, informalities or discrepancies. A work history detailing qualifications and past experience must be provided upon request.
