No such appeal as to the
amount of a special assessment
for a specific parcel of land may be
made unless the owner has filed
a written objection to that special
assessment, signed by the affected property owner, with the City
Clerk prior to the hearing or has
presented such a written objection
to the presiding officer at the public hearing. An owner may appeal a
special assessment to district court
pursuant to Minnesota Statutes,
Section 429.081 by serving notice
of the appeal upon the Mayor or
City Clerk within 30 days after the
adoption of the special assessment
and filing such notice with the district court within ten days after service upon the Mayor or City Clerk.

Special assessment amounts for

Special assessment amounts for specific parcels of land have been calculated in accordance with the City's Special Assessment Policy. These special assessments are now on file at City Hall with the City Clerk and open to public inspection. Written or oral objections to the proposed special assessments will be considered at this meeting, but the City Council may consider any objection to the amount of a proposed individual special assessment at an adjourned meeting upon such further notice to the affected property owners as it deems advisable.

DEFERRED SPECIAL

DEFERRED SPECIAL ASSESSMENTS

Under Minnesota Statutes,
Sections 435.193 to 435.195, the
City Council may, at its discretion,
defer the payment of some or all
of this special assessment for any
homestead property owned by a
person 65 years of age or older, or
by a person retired due to permanent and total disability for whom it
would be a hardship to make payment. The amount to be assessed
is based on the applicant's income.
