On or about November 4, 2024, Hennepin County will request the U.S. Department of Housing and Urban Development (HUD) to release HOME Investment Partnerships Program (HOME) funds under Title II of the National Affordable Housing Act, as amended, and Community Project Funding (CPF) under Public Law 117-328 of the Consolidated Appropriations Act, 2023, as amended, to undertake a project known as Twin Cittes Habitat for Humanity (TCHH) Mills Church Twin Homes as described below:

Twin Cities Habitat for Humanity will utilize approximately \$225,000 HOME 2023, \$264,491 HOME 2024, and \$400,000 Community Project Funds (CPF) 2023 funding to support the estimated total development cost \$6,775,184 for construction and sale of ten twin home units in Minnetonka. The homes will be located at 3521 Baker Road, Minnetonka, MN 55305 (PID 1511722420027), and adjoining parcels (addressey to be assigned) PIDs 1511722420028, and 1511722420028, 1511722420029, and 1511722420028. These units will be held in a land trust by Homes Within Reach (HWR) to ensure long term affordability. These ten units will comprise the Mills Twin homes project, where the next-door Mills Church is supporting Twin Cities Habitat in the effort to create long term affordable homeownership in Minnetonka.

costs not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint
