No bids will be considered unless sealed and filed with the City of Monticello and accompanied by a cash deposit, cashier's check, or certified check, or bid bond made payable to the City of Monticello for five percent (5%) of the amount bid, to be forfeited as liquidated damages in the event that the bid be accepted and the bidder fail to enter promptly into a written contract and furnish the required bond.

No bids may be withdrawn for a period of 60 days from the date of opening of bids. The City reserves the right to reject any or all bids.
