NOTICE IS HEREBY GIVEN, that sealed bids will be received by the Washington County Community Development Agency (the "Agency") until Tuesday, June 26, 2018 @ 10:00 AM at the offices of the Washington County CDA, 7645 Currell Blvd., Woodbury, MN 55125, at which time they will be publicly opened and read aloud for the furnishing of all labor and material for Trim Repairs and Paint to be done at the above mentioned property located in Washington County, including, but not limited to, the following:

**ANN BODLOVICK TRIM REPAIRS AND PAINT**

There will be a pre-bid meeting on Tuesday, June 12th at 12:00 a.m. at Ann Bodlovick Apartments, 2400 West Orleans Street, Stillwater, MN 55082. Interested contractors should attend the pre-bid meeting. There will not be any other opportunities to view the property with the architect and owner prior to the bid submission deadline.

Bids shall be on the forms provided for that purpose and according to the contract documents and instructions prepared by the Washington County CDA and Inside Outside Architecture, Inc. Bid forms and specifications are available from Inside Outside Architecture at 763-428-5870 or the Washington County CDA at 651-202-2820. Plans for review will also be available at the Minnesota Builders Exchange.

The required submission must include a 5% bid bond or a cashier's check in lieu of a bid bond, proof of insurance, and the bid form. The bids shall be directed to Kathryn Paulson, Washington County CDA, 7645 Currell Blvd., Woodbury, MN 55125, and shall be securely sealed, with the outside wrapper reading: "Bid for Ann Bodlovick Trim Repairs and Paint".

Prior to execution of a construction contract, the successful contractor will be required to submit a payment & performance bond in an amount equivalent to 100% of the contract, proper worker's compensation and general liability insurance coverage. Proposed date of construction contract letting is July 18th with Notice to Proceed July 25th with expected substantial completion by September 14th.

The Washington County CDA reserves the right to reject any and all bids, to waive irregularities and informalities therein and to award the contract in the best interest of the Washington County CDA. The CDA encourage bids from minority and women owned businesses.

**SEALED BIDS WILL BE OPENED ON Tuesday, June 26th at 10:00 a.m.** at the offices of the Washington County CDA, 7645 Currell Blvd., Woodbury, MN 55125.
