distribute real estate.

Any objections to the probate of
the will or appointment of the Per-
sonal Representative must be filed
with this Court and will be heard by
the Court after the filing of an ap-
propriate petition and proper notice
of hearing.

Notice is also given that (sub-
ject to Minn. Stat. § 524.3-801) all
creditors having claims against the
Estate are required to present the
claims to the Personal Represen-
tative or to the Court Administrator
within four months after the date
of this Notice or the claims will be
barred.
