HIGH SERVICE PUMP NO. 3 REPLACEMENT**

RECEIPT AND OPENING OF PROPOSALS: Sealed proposals for the work described below will be received by the Assistant City Engineer at the City Hall, 7800 Golden Valley Rd., Golden Valley, MN 55427 until February 14, 2019 at 11:00 a.m., at which time the bids will be opened and publicly read.

DESCRIPTION OF WORK: The work includes the following:

1. Provide one (1) new High Service Pump (HSP) and one (1) new HSP motor.
2. Replace all electrical conductors between the new motor leads and the motor starter.

COMPLETION OF WORK: All work under the Contract must be substantially complete by October 4, 2019 and complete by November 1, 2019.

MINIMUM CONTRACTOR QUALIFICATIONS: The Bidder shall have experience as a General Contractor in the successful completion of at least one high service pump replacement project within the last five (5) years. Minimum horsepower of the pump shall be 150 hp.

Bids will be received on a lump sum basis.

RESPONSIBLE CONTRACTOR: The successful bidder must be a "responsible contractor." The term "responsible contractor" means a contractor as defined in Minnesota Statutes, section 16C.285, subdivision 3. Any prime contractor, subcontractor, or motor carrier that does not meet the minimum criteria or fails to comply with the verification requirements is not a responsible contractor and is not eligible to be awarded a construction contract for the project or to perform work on the project. A prime contractor, subcontractor, or motor carrier that makes a false statement under oath verifying compliance with the minimum criteria will be ineligible to be awarded a construction contract on the project, and the submission of a false statement may result in termination of a contract awarded to a prime contractor, subcontractor, or motor carrier that submits the false statement. A prime contractor shall include in its verification of compliance a list of all of its first-tier subcontractors that it intends to retain for work on the project. Before execution of a construction contract, a prime contractor shall submit a supplemental verification under oath confirming that all subcontractors and motor carriers that the prime contractor intends to use to perform project work have verified to the prime contractor, through a signed statement under oath by an owner or officer, that they meet the minimum criteria for a responsible contractor.

BID SECURITY: A certified check or a Bid Bond satisfactory to the City of Golden Valley, Minnesota, in the amount of not less than 5 percent of the total Bid price submitted must accompany each Bid.

LABOR RATES - MINIMUM WAGE REQUIREMENTS: This project is being funded by the City of Golden Valley, Minnesota. The project is not subject to the provisions of Little Davis-Bacon Act.

PERFORMANCE AND PAYMENT BONDS: The successful Bidder will be required to furnish a Performance Bond and Labor and Materials Payment Bond each in the amount of the Contract.

The Bid, Agreement, and Bonds shall be conditioned upon compliance with all provisions of the Bid Documents.

PROJECT ADMINISTRATION: All questions relative to this project prior to the opening of bids shall be directed to the Engineer/Manager for the project. It shall be understood, however, that no specification interpretations will be made by telephone.
