No Bids will be considered unless sealed and filed with the City Clerk of Stillwater and accompanied by a cash deposit, cashier's check or certified check, or bid bond made payable to the City of Stillwater for five percent (5%) of the amount Bid, to be forfeited as liquidated damages in the event that the Bid be accepted and the Bidder fail to enter promptly into a written contract and furnish the required bond.

The provisions of Minn. Stat. 16C.285 Responsible Contractor are imposed as a requirement of this Contract. All Bidders and persons or companies providing a response/submission to the Advertisement for Bids/RFP of the City shall comply with the provisions of the statute.

No Bids may be withdrawn for a period of one hundred twenty (120) days from the date of Opening of Bids. The City of Stillwater reserves the right to reject any or all Bids.
