Notice is hereby given that sealed Bids will be received by the Richfield City Clerk, City of Richfield, until **1:30 p.m., Wednesday, March 27, 2019**, at the Richfield Municipal Center located at 6700 Portland Ave, Richfield, MN 55423, at which time they will be publicly opened and read aloud, for the furnishing of all labor and material for the construction of the City-wide water meter replacement project. The project is a multi-year contract to furnish Sensus brand replacement equipment, and install this equipment as replacement to the majority of the water meters throughout the city.
