Class of Work: Bituminous Paving, Milling, Demolition, Storm Sewer, Concrete, Curb and Gutter, Site Work

NOTICE TO CONTRACTORS

Sealed Bid Proposals for work indicated above will be received by the City of Rockford, in the City Hall at 6031 Main Street, Rockford, MN 55373, until 11:00 AM, Friday, March 29, 2019, after which time such bids will be publicly opened by the City Engineer(s) and Public Works Director and read aloud at the Rockford City Hall.

The "work", in accordance with Drawings and Specifications prepared by Wenck Associates, Inc., 1800 Pioneer Creek Center, P.O. Box 249, Maple Plain, Minnesota 55359, consists of all labor, materials, tools, permits, bonds, machinery, equipment, and services including utility and transportation services necessary for project completion.

In general, the "Work" consists of the following approximate quantities:

22,622	SY	Milling of Bituminous Pavement
1,350	LF	Replacement of Concrete Curb and Gutter
10	EA	Stormwater Structure Adjustments
2,300	TON	Bituminous Pavement
300	TON	Aggregate Base
700	SF	Replacement of Concrete Sidewalk
3	EA	Pedestrian Landings

Together with traffic control, casting adjustments, site restoration, driveway patching, erosion control and other related appurtenances.

Each bid proposal shall be accompanied by a "Bid Security" in the form of a certified check made payable to the "CITY OF ROCKFORD" (OWNER) in the amount not less than five percent (5%) of the total bid, or a surety bond in the same amount, running to the OWNER, with the surety company thereon duly authorized to do business in the State of Minnesota. Such Bid Security to be a guarantee that the bidder will not, without the consent of the OWNER, withdraw his bid for a period of Sixty (60) days after the opening of bids, and, if awarded a contract, will enter into a contract with CITY OF ROCKFORD; and the amount of the certified check will be retained or the bond enforced by the OWNER in case the bidder fails to do so. All bid securities except those of the three lowest eligible bidders will be returned within five days after the opening of bids.

Lowest Eligible Bidders for this project must meet the Minimum Criteria as defined in the Responsible Contractor Requirement in accordance with Minnesota Statutes § 16C.285, subdivision 3, and additional criteria required by the City of Rockford. Submitted Bids must be accompanied by a completed Responsible Contractor form provided in these materials.

Bid Proposals shall be submitted on forms furnished for that purpose. Bids shall be submitted in sealed envelopes with the following clearly inscribed on the outside: "Bid Proposal for: 2019 STREET IMPROVEMENTS, CITY OF ROCKFORD." No bidder shall withdraw his bid(s), without the consent of the OWNER, for a period of sixty (60) days after the date for the opening thereof. The OWNER reserves the right to reject any or all bids and to wave any irregularities, informalities, or discrepancies in its sole discretion. It is agreed upon and understood by the Contractor that the contents of the submitted bid(s) and any clarification to the contents submitted by a Contractor will become a part of the contractual obligation and will be incorporated by reference into the final contractual agreement(s). By submitting a bid, the Contractor is agreeing to accept the terms and conditions provided herein, including any errors or omissions made during this process. A work history detailing qualifications and past experience shall be provided within 7 days if requested by OWNER.

The project, if awarded is anticipated to start in June of 2019 and with project completion by September of 2019. Performance and Payment Bonds will be required of the awarded contractor as stated in the bidding documents.
