and administering tax-forfeited lands on behalf of the State of Minnesota; and WHEREAS, the Isanti County Auditor-Treasurer is statutorily responsible for various duties related to administering tax-forfeited property sales; and WHEREAS, Minnesota Statutes, §282.135 allows the county board to delegate to the county auditor any authority, power, ore responsibility relating to the administration of tax-forfeited land; NOW THEREFORE BE IT RESOLVED, that Isanti County Board of Commissioners hereby formally delegates the continued administration of tax-forfeited properties to the Isanti County Auditor-Treasurer; BE IT FURTHER RESOLVED, the delegation of administration of tax-forfeited properties to the Isanti County Auditor-Treasurer specifically includes, but is not limited to, authorization to perform any action the Isanti County Auditor-Treasurer deems necessary to proceed with the eviction of individuals from tax-forfeited property.
