tection Rule 21.01 or an attorney
for a party; or
- You have physical custody of
the child who is the subject of the
Petition; or
- You are a person whose pres-
ence the court believes is important
to a determination concerning the
best interests of the child(ren) who
are the subject of the Petition.

IF YOU FAIL TO APPEAR AT
THE HEARING:

- The court may conduct the
hearing without you; and
- The court may find that the
factual allegations and statutory
grounds set forth in the petition
have been proved; and
- The court may enter an order
granting the relief requested in the
petition, which may include:
 - o removing the child(ren) from
the home of the parent or legal cus-
todian and placing the child(ren) in
foster care;
 - o permanently severing the par-
ent's rights to the child(ren) pur-
suant to a termination of parental
rights petition;
 - o permanently transferring the
child(ren)'s legal and physical cus-
tody to a relative; or
 - o an order for other permanent
placement of the child(ren).
