Notice is hereby given that the Planning Commission will be conducting a public hearing on Tuesday, December 18, 2018 at 7:00p.m. at the Rogers Community Room located at 21201 Memorial Drive, to consider a request by the City of Rogers for a preliminary and final plat for Outlots A-G, Edgewater Second Addition.
