NOTICE IS HEREBY GIVEN that sealed bids will be received at the office of the City Clerk in the City of Richfield, Hennepin County, Minnesota until 9:00 a.m. on the 7th day of March, 2019 and will be publicly opened and read aloud by the City Clerk in the Babcock conference room of the Richfield Municipal Building on the above date, said bids to be for furnishing of all labor and materials for the construction and installation, complete in place of the following local improvement under Minnesota Statutes, Chapter 429:

Bituminous milling and overlay of approximately 15 miles of residential city streets and all appurtenant work as specified herein in accordance with specifications on file in the office of the City Engineer, 1901 E 66th Street, Richfield, Minnesota, 55423.

Approximate quantities are:

265,000 SY of Mill Bituminous Surface
40,000 Tons of Hot Mix Asphalt

Bids arriving after the designated time will be returned unopened.

All bids shall be made on the proposal forms of the City and shall be accompanied by a cashier's check, bid bond or certified check, payable to the City of Richfield for five percent of the amount of bid to be forfeited as liquidated damages in the event that the bid is accepted and the bidder shall fail to enter promptly into a written contract and furnish the required bond.

Each bid and all papers bound and attached thereto, together with the bid guarantee, shall be placed in an envelope and securely sealed therein. The envelope shall be so marked as to indicate the name of the bidder and the project name and shall be addressed to the City Clerk, City of Richfield, 6700 Portland Avenue South, Richfield, Minnesota, 55423. It may be mailed, delivered by messenger or submitted in person.
