The Holidays to be open are Memorial Day, Forth of July, Labor Day, and New Year's Eve. Findings: 1. This parcel of land is covered with a natural buffer of pine trees so that the conditional use will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purpose already permitted, nor substantially diminish and impair property values within the immediate vicinity. 2. This is a permitted use in the Agriculture/ Residential District with a Conditional Use Permit issued so the establishment of the conditional use will not impede the normal and orderly development and improvement of surrounding vacant property for uses predominant in the area. 3. The drainage and access roads have been addressed so that adequate utilities, access roads, drainage and other necessary facilities have been or are being provided. 4. No off-site parking will be allowed so that adequate measures have been or will be taken to provide sufficient off-street parking and loading space to serve the proposed use. 5. There will be cut-off lighting at the property lines, amplified music will only be allowed for outdoor weddings otherwise will be kept indoors, and will meet the Minnesota State Statue for noise so that adequate measures have been or will be taken to prevent or control offensive odors, fumes, dust, noise and vibration so that none of these will constitute a nuisance, and to control lighted signs and other lights in such a manner that no disturbance to neighboring properties will result.
