A resident from Page Township questioned the property tax rates for Page Township and the evaluation rates for their properties. The resident stated that on the township road 220th Street that from the

flood two years ago the road was never completely fixed where it was washed out. The resident is disput-

A resident from Bogus Brook Township addressed the Board. The resident agreed that the County Board salaries should be increased as it will also attract high quality candidates. The next item the resident discussed was general public hearings stating that having the ability to speak in front of the Board is very important to the public and would like to see more of it during regular County Board meetings. The resident asked for the County Boards perspective on the revoking of the 2008 Cooperative Agreement with the Mille Lacs Band of Ojibwe, the financial impact and the benefit of it. County Administrator Oman stated all the information is on the County website in regards to the revoking of the 2008 Cooperative Agreement. County Administrator Oman reviewed there was an investment made in 2016 to increase the number of County Deputies. The number has not increased, but has remained a consistent expense.
