AND SAFETY REGULATIONS Repealing the existing Soo Line Trail Rules and Safety Regulations in their entirety and adopting the following Soo Line Trail Rules and Safety Regulations, establishing Sections 2-565 through 2-581: Sec. 2-565 – Authority: establishes the authority to manage the activities within the Soo Line right of way. Sec. 2-566 – Jurisdiction, Lands Governed: provides for the legal descriptions of the lands governed by the ordinance. Sec. 2-567 – Definitions: defines certain terms specific to the ordinance. Sec. 2-568 – Authorized Uses Without Permit: establishes the uses of the trail allowed without a permit.

Sec. 2-569 – Authorized Uses,
Short or Long Term Permit Required: establishes the uses of the trail requiring issuance of a permit. Sec. 2-570 – Unauthorized Unauthorized Uses: establishes the uses prohib ited on the trail.

Sec. 2-571 – Short or Long Term
Special Permits: establishes a process for applying and receiving a permit. Sec. 2-572 - Trail Plowing: establishes minimum snow depth that is to be maintained on the trail. Sec. 2-573 – Firearms: prohibits discharge of firearms or bows across trail right of way.

Sec. 2-574 – Trail Signs: establishes signs along the trail.

Sec. 2-575 – Fences: establishes standards for placement of fences along the trail. Prohibits fences from crossing the trail.

Sec. 2-576 – Safety: establishes safety standards for use of the trail.

Sec. 2-577 – Special Events:
requires a permit for special event use of the trail.

Sec. 2-578 – Enforcement: es tablishes the enforcement responsibilities of the Soo Line Trail Administrator and Sheriff

Sec. 2-579 - Violation and Penalty: establishes the penalty for vio-

lating the ordinance.

Sec. 2-580 – Validity: establishes that if one portion of the ordinance is declared invalid, it does not render the entire ordinance invalid.
