NOTICE IS HEREBY GIVEN that sealed bids will be received by the City of Lakeville at the office of the City Clerk until 2:00 p.m. CST, Friday, December 6, 2024, at the Lakeville City Hall, 20195 Holyoke Avenue, Lakeville, MN 55044, and will be publicly opened and read at said time and place by representatives of the City of Lakeville. Said proposals are for the furnishing of all labor and materials for the construction, complete in-place, of the following approximate quantities:

1 LS Mobilization
45,577 LF 2" Dia. Lateral Drainage Line
3,763 LF 4" Dia. Collector Drainage Line

The bids must be submitted on the Proposal Forms provided in accordance with the Contract Documents, Plans, and Specifications dated November 15, 2024, as prepared by SRF Consulting Group, Inc.

Complete digital Proposal Forms, Plans, and Specifications for use by contractors submitting a bid will be available at www.questcdn.com on November 15, 2024. You may download the digital plan documents for a nonrefundable fee of \$22.00 by inputting Quest project #9420012 on the website's Project Search page.

An optional paper set of Proposal Forms, Plans, and Specifications may be obtained from SRF Consulting Group, Inc., at 3701 Wayzata Boulevard, Suite 100, Minneapolis, MN, 55416, for a nonrefundable fee of \$150.00 per set.

Bids will only be accepted from contractors who purchase digital or paper bidding documents as specified above.

No bids will be considered unless sealed and filed with the City Clerk of Lakeville and accompanied by a cash deposit, cashier's check, certified check, or bid bond made payable to the City of Lakeville for five percent (5%) of the amount bid, to be forfeited as liquidated damages in the event the bid is accepted and the bidder fails to enter promptly into a written contract and furnish the required bond.

The City of Lakeville reserves the right to reject any and all bids, waive any informalities in bidding and to accept the bid or bids which best serve the interests of the City. No bids may be withdrawn for a period of sixty (60) days from the bid opening date.

CONTRACTOR ACKNOWLEDGEMENTS:

(1) Any prime contractor or subcontractor that does not meet the minimum criteria established for a "responsible contractor" as defined in Minn. Stat. § 16C.285, subd. 3, or fails to verify that it meets those criteria is not a responsible contractor and is not eligible to be awarded a construction contract for the project or perform work on the project.

(2) Responsible contractors shall submit to the City a signed statement under oath by an owner or officer verifying compliance with each of the minimum criteria in Minn. Stat. § 16C.285, subd. 3, at the time that it responds to this solicitation document.

(3) A prime contractor shall submit to the City, upon request, copies of the signed verifications of compliance from all subcontractors.

(4) A false statement under oath verifying compliance with any of the minimum criteria shall make the prime contractor or subcontractor that makes the false statement ineligible to be awarded a construction project and may result in termination of a contract awarded to a prime contractor or subcontractor that submits a false statement.
