NOTICE IS HEREBY GIVEN IN ACCORDANCE WITH THE PROVISIONS OF Section 905 of the Act of June 3, 1937, P.L. 1333, as amended, known as the Pennsylvania Election Code, that nominations are to be made to fill the following named offices at the General Primary to be held throughout Blair County at the regular polling places on Tuesday, May 19, 2026 A.D. between the hours of 7 o'clock a.m. and 8 o'clock p.m. (prevailing time) and elected to office at the General Election on Tuesday, November 3, 2026.
