AGREED ORDER GRANTING JOINT MOTION OF SEMICONDUCTOR COMPONENTS INDUSTRIES, LLC, DEFENDANTS, AND THE RECEIVER TO APPROVE SETTLEMENT

This matter came before the Court pursuant to the *Joint Motion of Semiconductor Components Industries, LLC Defendants, and the Receiver to Approve Settlement* (the “Motion”) filed by Plaintiff Semiconductor Components Industries, LLC (“onsemi”); Defendants LA Semiconductor, LLC (“LAS”), Mike Ward (“Ward”) and Linear Asics Inc. (“Linear” and collectively with LAS and Ward, the “Defendants” and with onsemi, the “Parties”); and FTI Consulting, Inc. (the “Receiver”) as Receiver for LAS. The Court having reviewed the Motion and the relief requested therein, hereby FINDS as follows (a) notice of the Motion and the relief requested therein was just and proper; (b) the Parties, having engaged in settlement negotiations culminating the Motion, the Settlement Agreement and this *Agreed Order Granting Joint Motion of Semiconductor Components Industries, LLC Defendants, and the Receiver to Approve Settlement* (the “Agreed Order”), have determined that resolving their respective disputes pursuant to the Settlement Agreement and this Agreed Order is in their respective best interests and avoids the cost, expense, delay, and uncertainty of litigation; and (c) the relief requested in this Motion is

just and proper. Now, THEREFORE, based on the foregoing FINDINGS, it is hereby ORDERED, ADJUDGED, and DECREED as follows:

1. Motion Granted. The Motion is GRANTED as set forth herein.
2. Capitalized Terms. Unless otherwise defined or stated in this Agreed Order, capitalized terms used but not defined in this Agreed Order shall have the meanings ascribed to them in the Motion or incorporated by reference into the Motion.
3. Approval of Settlement Agreement. The Settlement Agreement is approved in all respects. The Parties are authorized and directed to pay and perform their respective obligations under the Settlement Agreement when and as provided in the Settlement Agreement.
4. Full Faith and Credit. This Agreed Order (a) is entitled to full faith and credit in all federal, states, county, local, territorial, and administrative courts, forums, venues, and tribunals; (b) may be enforced in any manner in which judgments may be enforced (i) domestically (including, without limitation, in any state, county, city, municipality, or township in the United States); (ii) in any territory of the United States; or (iii) internationally; and (c) shall be binding upon, and inure to the benefit of, the Parties in any and all future cases, causes, and proceedings of any kind (the foregoing provisions, the “Full Faith and Credit Provisions”).
5. Retention of Jurisdiction. Without in any way limiting any of the Full Faith and Credit Provisions, this Court hereby retains non-exclusive jurisdiction to interpret or enforce this Agreed Order.

THIS AGREED ORDER IS FINAL. IT IS SO ORDERED.
