On 12/14/18 at about 1115 hours I (Det. Mike Marvin) was contacted by Bingham County Sheriff Craig Rowland telling me I needed to respond to the Bannock County Jail in regards to an in custody death. I was told Tri-County investigators would be assigned to this case. Sheriff Rowland texted me the contact information as to who to contact at Bannock County Sheriff's Office. I found the contact person would be Bannock County Detective Casey Craig.

While responding I called Det. Craig and found out I would be assisted by Fremont County Sheriff's Detective Bruce Mattingly. I was also told the victim later identified to be Lance A. Quick has been transported to Portneuf Medical Center in Pocatello, Idaho and there were Deputies with Mr. Quick. I was informed Mr. Quick's father is Kim Quick who is the Bannock County Coroner. It was decided I would go to the Bannock County Sheriff's Office for a briefing of the incident. I called Det. Mattingly and found he would be about another 2 hours before he could arrive so I told him I was going to start the investigation and I would fill him in when he arrived.

After meeting with Det. Craig and Bannock County Detective Alex Hamilton I found out the following. Mr. Quick was arrested on 12/08/18 by Pocatello Police for DUI. I was told Mr. Quick was exhibiting bazaar behavior during this time. Mr. Quick had been placed into a holding cell with limited items. I also learned Mr. Quick had not eaten or drank any fluids in the last 4 days. Mr. Quick was not responding to Detention Staff verbally during his time of incarceration. Mr. Quick had been seen by a Designated Examiner Marty Cooke according to documents on 12/13/14 where he would not respond to questions and therefore a commitment hearing was held this date in the Bannock County Jail where Judge Bryan Murray signed the order for Mr. Quick to be transported to State Hospital South in Blackfoot, Idaho.

I was told Mr. Quick's behavior indicated he was a risk to himself. During Mr. Quick stay in the jail he would disrobe and was naked most of the time. I was also told Detention Staff would do a 15 minute cell check and during the checks Mr. Quick was asked if he wanted any food or water and he would not respond. I found the last time Mr. Quick had eaten was on 12/11/18 and it was diner. During the cell check at 1005 hours this date the Close Custody Watch Log indicates Mr. Quick was on his belly breathing. At 1021 hours during the next cell check Mr. Quick was reported as not breathing. During this time detention Staff along with Medical Staff entered the holding cell and CPR was done along with other life saving measures being administered. An ambulance was dispatched and Mr. Quick was transported to Portneuf Medical Center where at the current time there was no word as to Mr. Quick's status.

I was provided with several documents including the commitment order, arrest report, jail records and statements from the Detention Staff. A phone call was made to the Deputy at the hospital and it was found that Mr. Quick was pronounced deceased. I was told the holding cell Mr. Quick was in had been secured and no could enter the cell. I was also told there were recordings of the holding cell showing Mr. Quick's movement through the day.

It was decided at this point I would respond to Portneuf Medical Center to collect any evidence if needed and to photograph Mr. Quick's body. Det. Craig and I arrived at the hospital and meet with Ely Taysom Bannock County Deputy Coroner. In the emergency room I could also see Kim Quick and another person whom I believed was Kim's wife. Mr. Quick had already been placed into a body bag and the hospital was in

the process of taking Mr. Quick to the morgue. Also present was Bannock County Deputy Jarod Shaffer who had went with Mr. Quick in the ambulance when he was transported.

Present in the morgue when we took Mr. Quick there to get some pictures was Mr. Taysom, Det. Craig, Coroner Kim Quick and myself. At this point the body bag had not been sealed so I unzipped it to take photos. When the bag was opened I could see Mr. Quick was wrapped in a blanket with a towel over his head. Mr. Quick still had medical supplies attached to his person. I took a few photos and decided not to uncover Mr. Quick as I knew an autopsy would be performed. The body bag was then zipped up and sealed with a Bingham County Coroner wire tag #0001042. Mr. Quick's body was then placed into a refrigeration unit and evidence tape was placed on the door. I later found an autopsy would be done on 12/17/18 at 0900 hours at the Ada County Coroner's Office in Boise, Idaho.

I returned to the Bannock County Sheriff's where Det. Mattingly interviewed the Detention Staff and I processed the scene and gather all other pertinent information. Det. Craig took me into the booking area of the jail. Cell number 8 was the cell Mr. Quick was in which is across from the booking desk. The door was secured and a hand written note on the door that says DO NOT TOUCH OR OPEN CELL DOOR.

Det. Craig activated the lock to the cell and I opened it finding nothing in the cell. I photographed the cell along with showing the security camera in the cell. The cell measures 10 feet 10 inches by 6 feet. It was found during the life saving measures an AED defibrillator was used by Allison Jorgenson with Ivy Medical. The AED used was then located in the Medical Department of the Jail. We removed the SIM card from the AED and it was downloaded and a copy of the report will be attached. Ms. Jorgenson said her only interaction with Mr. Quick was this date during the incident.

In looking at the jail logs it shows cell checks were completed and at 0932 hours the log indicates Mr. Quick was awake on his left side breathing. At 0952 Mr. Quick was awake and breathing but not responding to Detention Staff. At 1005 hours the log says Mr. Quick was breathing on his belly. At 1021 hours the log shows Mr. Quick was not breathing. Most of the log from 0003 hours show he was sitting on the floor and was offered something to drink but Mr. Quick would not respond.

Det. Craig obtained 3 hours and 13 minutes of records from the holding cell Mr. Quick was in. This recording was later reviewed and I found the recording date was on 12/14/2018 and the time of recording shows from 14:29:45 to 17:42:44. I believe this time indicates UTC time which is 6 hours ahead of our local time. I will verify this with Bannock County at a later time.

On 12/17/18 at 0900 hours I along with Det. Mattingly and Coroner Gardner attended the autopsy. Dr. Garth Warren performed the procedure. After the autopsy was completed Dr. Warren said he would not be able to give a cause of death until all lab work was completed. Dr. Warren said he was not going to rule out dehydration as a factor however the report from Dr. Warren will take 6 to 8 weeks to be completed.

On 12/18/18 Bingham County Deputy Coroner Deb Wright and I went to the Bannock County Jail where Coroner Wright obtained a copy of the medical records from the jail. The records indicate Mr. Quick was seen 3 times during his stay in the Jail. The first time was on 12/11/18 at 1815 hours. It says the Jail Staff asked medical to assess Mr. Quick. It also reported Mr. Quick was hitting his mattress and talking

incoherently. During this time Mr. Quick laid down on his mattress and was acting like he was swimming. It was also noted Mr. Quick charged the Deputy and the door was closed.

On 12/13/18 medical attempted to assess Mr. Quick again and during this time Mr. Quick was offered Gatorade and he declined it. Medical then contacted Kenneth (unknown last name on report) with Mental Health Kenneth apparently checked Mr. Quick and then told Medical Mr. Quick was going to be transferred to State Hospital South.

The next entry by medical was on 12/14/18 when Mr. Mr. Quick was found non responsive. The report says Deputies were performing CPR and Medical rendered aid as well. See medical report for details.

On 12/19/18 after returning to the office where I viewed more of the recording from the holding cell Mr. Quick was in. I was still having some difficulty with the time stamp on the recording. I called Det. Craig to confirm the times on the recording. Det. Craig explained I was watching the recording in the wrong format so he was bringing me another thumb drive. Once Det. Craig arrived he told me the time stamp in the upper left hand corner was incorrect. Det. Craig told me the counter at the bottom of the recording is real time. The recording is from 0000 hours to 1058 hours on 12/14/18.

In brief the recording shows Mr. Quick on the cement floor most of the time. Mr. Quick was not wearing any clothing but at times was covered with a blanket provided by the jail. When Mr. Quick was awake he was making bazaar movements not staying in one place very long. It also appears Mr. Quick was issued a jail mattress but did not use it often. Mr. Quick continually moved around on the floor lying directly on the cement floor. Mr. Quick did not stay in one position very long mostly moving every couple of minutes. At approximately 0321 hours it appears a Detention Officer places a Styrofoam cup in the door hatch the cup is removed at 0323 hours without Mr. Quick taking a drink.

At about 0640 hours a food tray was placed in the hatch by a Detention Officer. Mr. Quick did not appear to respond to this as he continued to move around on the floor and the tray was removed at about 0643 hours. At about 0954 hours Mr. Quick rolls on to his back in the center of the cell. Then at 1001 hours Mr. Quick appears to be taking breaths out of his mouth as his head moves with each breath. By 1004 hours Mr. Quick appears to be taking short labored breaths. At 1019 hours Mr. Quick appears to take his last breath and was found in this state at 1023 hours when Sgt. Michael J. Shelton entered the cell and attempted to get a response out of Mr. Quick. Sgt. Shelton immediately started CPR. Ms. Jorgenson enters the cell at 1024 hours and at 1026 hours the AED was placed on Mr. Quick's chest. A short time later CPR was initiated again. As Personnel started to arrive all items in the cell were removed such as the mattress and jail clothing. The AED was used a second time at 1030 hours which it did not look like it provided a shock.

At 1032 hours EMS Personnel arrived and took over life saving measures from Jail Staff. At 1034 hours Mr. Quick was removed from the cell where EMS continued medical aid and at 1042 hours Mr. Quick was removed from the Jail and transported to Portneuf Medical Center.

In looking through the jail logs I found an entry made on 12/11/18 at 0545 hours in which Mr. Quick was asked by Deputy T. Ranere if he (Mr. Quick) was withdrawing from anything. Mr. Quick responded "Oh God, Yes. He then went on to talk about a

beach house which Jodi (unknown last name) and he had and she took it. Deputy Ranere was unable to book Mr. Quick into jail. On this same date at 1416 hours Deputy A E Luce was told by Lt. Johnson to have medical talk with Mr. Quick and Nurse Melonie was told of this request. Also an order was sent to Judge Murray and HDC (unknown what this is) after the order was signed. Mr. Quick did drink two cups of water this date and he poured the third cup on his mattress at 2318 hours.

On 12/12/18 at about 0640 hours Mr. Quick was offered a food tray which he took and put it down the drain. A couple hours later Mr. Quick was moved cell 8 to cell 7 so the cell could be cleaned. It was during the clean up a working inmate found the mattress MR. Quick was issued was covered in feces. Mr. Quick exhibited more bizarre behavior later in the morning by dancing around the cell naked and making snow angles on the cell floor. Mr. Quick also became aggressive when trying to move him from one cell to another.

One this same date at 1937 hours Deputy C. Topliff called Portneuf Medical center to speak with a BHAT worker about Mr. Quick's behavior and was told someone would have to call him back when a BHAT worker was available. It appears Deputy Topliff was told Mr. Quick would need to be transported Portneuf Medical Center to start the process. There was a conversation about who would be responsible for transporting Mr. Quick to the hospital rather it would be a transport business or a law enforcement officer and it was decided the hospital would have to make a decision on this. At 2209 hours Cindy who is a BHAT worker called back and said all units except BHC are on divert and BHC will not accept Mr. Quick. Deputy Topliff was told by Cindy that he would have to call back 12/13/18 after 0930 hours to see if a room has opened up.

At 2114 hours Mr. Quick was offered another cup of water and he took it and poured it out on the floor. Mr. Quick was offered more water on this date and he refused it. On 12/13/18 Mr. Quick was offered meals and water throughout the day but he would not acknowledge Deputies at all. At 1843 hours Deputy L. Hapke noticed several bruises and red welts on Mr. Quick's buttocks but did not indicate how he may have received them but after watching the recording it is possible the bruising came from Mr. Quick rolling around on the floor.

On 12/14/18 at 0650 hours Deputy R E Vandyke gave Mr. Quick his food tray and in this log it says Mr. Quick was unable/unwilling to retrieve the breakfast tray from the hatch. Mr. Quick at this time was rolling around on the floor and then sat against the wall. The last time Mr. Quick was offered water was at 0955 hours which he did not respond to the Deputy.

Attached to this report are the jail records, medical records from the jail, AED logs and copies of statements from the Detention staff. See Det. Mattingly's report on the interviews.

I hereby certify that on the 17th day of December, 2018, beginning at 0930 hours, I, Garth D. Warren, M.D., performed an autopsy on the body of Lance Quick at the Ada County Coroner's Office in Boise, Idaho and upon investigation of the essential facts concerning the circumstances of the death and history of the case, I am of the opinion that the findings, cause and manner of death are as follows:

COMMENT: The decedent was a 40-year-old male with a history of . He was arrested by law enforcement in Pocatello, Idaho and taken into custody on 12/08/2018 for reportedly driving under the influence (DUI) and entering the backyards of residences that did not belong to him. The decedent was placed in a holding cell by himself at the Bannock County Jail. The decedent remained alone in his cell from 12/08/2018 to 12/14/2018, during which time he reportedly did not eat or drink anything. He also reportedly talked incoherently, was unaware of his environment, and was unresponsive to questions. On 12/14/2018, he was found by jail staff lying on his back in the middle of his cell, unresponsive and not breathing. Resuscitation efforts were performed by jail staff until EMS responded, who continued resuscitation efforts and transported the decedent to a local hospital where he was diagnosed with severe metabolic and respiratory acidosis and hyperkalemia. The decedent was pronounced dead in the emergency room despite resuscitation efforts.

Autopsy revealed evidence of medical intervention and cutaneous bruises and abrasions scattered on the forehead, torso and extremities. No traumatic injuries were identified internally. Autopsy also revealed pulmonary vascular congestion with patchy alveolar hemorrhage.

Toxicology was performed on two separate blood samples (one sample obtained on 12/08/2018 by law enforcement while the decedent was in custody; one sample from the hospital obtained on 12/14/2018). The sample from 12/08/2018 showed marijuana metabolites, lamotrigine and caffeine. The sample from 12/14/2018 showed marijuana metabolites, lamotrigine, naloxone and elevated acetone levels. Naloxone was administered during resuscitation efforts.


Vitreous fluid analysis was significant for marked hypernatremia (indicative of hypernatremic dehydration) and markedly elevated levels of creatinine and urea nitrogen (indicative of renal failure). Glucose was not detected in the vitreous fluid.

Based on the available history, medical records, jail and law enforcement records, postmortem examination, toxicology and vitreous fluid analysis, the cause of death is due to complications of hypernatremic dehydration and ketoacidosis secondary to prolonged period without food or water.

CLOTHING AND PERSONAL EFFECTS: The body is received in a sealed blue body bag; tag #0001042. A tan identification tag, inscribed with the decedent's name, DOB 11/9/78, DOD 12/14/18, TOD 1123 am, is fastened to the outside zipper of the bag with white string. An identification tag is also fastened around the left thumb with a white string. A gray blanket is draped over the body, a blue sheet is underneath the body, and a white towel is draped over the top of the head. The body is received unclothed at the time of the exam. No jewelry or personal effects are present on the body at the time of the postmortem exam.

A tox box, sealed with evidence tape, and a requisition form accompany the body outside of the body bag. The tox box is labeled with Pocatello Police, a law enforcement case number, decedent's name, sample collected by and a chain of custody worksheet. The tox box contains two gray top tubes of blood, both labeled with the decedent's name, B. McClure and 12-8-18. A blood draw consent form is within the box as well, labeled with the decedent's name, date 12-8-18, time 1915 and a signature of B. McClure.

IDENTIFICATION:

- Identification is made circumstantially prior to the postmortem examination.
- Fingerprints and digital photographs are obtained.

MEDICAL INTERVENTION:

- Endotracheal tube protrudes from the mouth, fastened around the face with a plastic harness and Velcro strap.
- Orogastric tube protrudes from the mouth.
- Multiple adhesive EKG lead pads are scattered on both sides of the chest and abdomen.
- Defibrillator pads are present on right upper chest and lateral left trunk.
- Single lumen catheter inserted in the lateral right lower neck.
- Blood pressure cuff around the right upper arm.
- Left intraosseous tibial stick, attached by tubing to a nearly full saline bag.
- Foley catheter inserted in the urethra, affixed to the medial right thigh, and attached by tubing to an empty urine collection bag; clear yellow urine is noted within the tubing.
- Single lumen catheter inserted in the proximal anterior left forearm.
- Pulse oximeter on right pointer finger.
- Alcohol prep pad and small piece of gauze are within the body bag.
- Three healing needle puncture marks in the left antecubital fossa with surrounding faint purple bruising.
- Displaced right anterior ribs #3-8; displaced left anterior rib fractures #4-6.

EXTERNAL BODY EXAMINATION: The body is that of a well-developed, thin male who appears the reported age of 40 years. The body weighs 149 pounds and is 65 inches in length (Body mass index of 24.79 kg/m²). The body is cool to the touch having been temporarily refrigerated. Rigor is well developed in the jaw and extremities. Lividity is red-purple, fixed and present in the posterior dependent portions of the body except in areas exposed to pressure. Evidence of early decomposition includes a focal area of faint green skin discoloration measuring 1 x 1-inch involving the right lower quadrant of the abdomen.

The scalp hair is brown and cut short to the scalp with early frontal balding. The irides are hazel, the pupils are equal and round bilaterally and the corneas are clear. The sclerae are white with no congestion. There are no obvious bulbar or palpebral petechial hemorrhages. The nose is normally formed and does not grate upon palpation with a small amount of clear mucus in the nostrils. The ears are normally formed and set without blood or discharge in the external auditory canals. No earlobe creases are identified. The decedent wears a medium length brown/gray beard and mustache. The mouth, lips and lining of the mouth are normally formed with tooth indentions along the lower lip. The mucous membranes are dry. The anterior teeth are natural, intact and in a fair state of repair. The anterior neck is normally formed. The trachea is midline to palpation and the neck is free of palpable masses, cervical lymphadenopathy or obvious traumatic injuries.

The body hair pattern is appropriate for age and sex. The chest is well developed. The nipples are symmetrical and unremarkable. The abdomen is flat, firm and free of palpable masses. The external genitalia are those of a normal adult male. The testicles are descended in the scrotum. The pubic hair pattern is appropriate for age and sex.

The upper extremities are symmetric and normally formed with all five digits on each hand. All needle puncture marks appear to be therapeutic. The fingernails are natural, intact and extend to the tips of the fingers with minimal underlying debris. The lower extremities are symmetric and normally formed with all five toes on each foot. The toenails are natural, intact and extend to the tips of the toes; the first two right toenails are chipped and cracked. The soles of the feet are dried with a thin film of a gray substance on the bottoms of both feet.

The back and anus are normally formed.

SCARS AND TATTOOS:

Scars:

- Vertically oriented, well healed linear scar measuring 2 inches on posterior midline of the lower back.

Tattoos:

- Black flag design on lateral left shoulder/upper arm.
- Multicolored fire rescue design with names and dates on left lateral shoulder.
- Blue/red wrestling design and "QUICK" on the upper back.
- Multiple black dots and indecipherable objects on the back of the right 2nd, 3rd, 4th and 5th fingers.

EVIDENCE OF INJURY:

I. Head and neck:

A. External:

- Irregular, brown, healing and crusted superficial abrasion measuring ¼-inch on left lower forehead, just above the left eyebrow.
- Linear, interrupted, red superficial abrasion measuring 1¼ inches on right lateral neck; faint purple bruising measuring 2 x 1½ inches surrounds the abrasion.
- Red-brown superficial abrasion on the inner mucosa of the left upper lip near the corner of the mouth; pink-red superficial abrasion on the inner mucosa of the right upper lip near the corner of the mouth.

EVIDENCE OF INJURY, cont.**II. Torso:****A. External:**

- Large collection of yellow-orange waxy superficial abrasions spanning a total area of 6 x 6 inches on the right lower chest; similar appearing collection of yellow-orange waxy superficial abrasions measuring 4 x 2½ inches along the left lower ribcage.
- Numerous punctate, red-brown superficial abrasions spanning a total area of approximately 8 x 5 inches scattered on the lower ribcage and upper abdomen.
- Red-red bruise measuring 4 x 2 inches on the anterior right hip.
- Pink-red to red brown bruise measuring 3½ x 2½ inches on the anterior left hip.
- Collection of red-purple bruising measuring 4 x 2 inches involving the left lateral hip.
- Light brown bruises, ranging in size from 1 to 3 inches, involving the posterior midline of the lower back and left lower back.

III. Extremities:**A. External:**

- Two faint red-purple ovoid bruises, measuring ½ and ¾-inch in diameter, involving the distal left triceps region, just above the left elbow.
- Collection of pink-red bruising measuring 2½ x 1-inch involving the posterior aspect of the proximal right forearm.
- Faint purple bruise measuring 1 x ¾-inch involving the anterior aspect of the mid right forearm.
- Pink-red bruising measuring 3¼ inches in length x 1½ inches in width involving the anterior right wrist.
- Multiple irregular and linear, red-brown, dried superficial abrasions ranging in size from 1/16 to ¼-inch on the knuckles of the right 2nd, 3rd, 4th and 5th fingers; faint red-purple bruising is associated with most of the abrasions.
- Brown, dried, partially scabbed superficial abrasion measuring 3/16-inch involving the back of the right hand, near the base of the pointer finger.
- Collection of pink-red bruising spanning a total area of 3 x 1½ inches involving the right thumb, right anatomical snuffbox and a portion of the back of the right hand; multiple small superficial abrasions are scattered within the bruising on the back of the right hand.
- Three small pink-red superficial abrasions ranging from 1/16 to 3/16-inch involving the back of the left thumb, near the base of the thumb.
- Dark red-brown superficial abrasion measuring 3/8 x 3/8 inch involving the back of the left pinky finger.
- Irregular, brown, dried superficial abrasion measuring 1/8-inch involving the back of the left hand, between the third and fourth knuckles.
- Collection of pink-red bruising and superficial abrasions measuring 4¼ x 3½ inches involving the right knee.
- Faint pink-red bruise measuring 3 x 1½ inches involving the proximal left shin.
- Collection of pink-red bruises and small superficial abrasions spanning a total area of 4 x 2½ inches involving the left knee.
- Multiple red-purple bruises ranging in size from 1 to 3 inches in greatest dimension involving the distal right shin, medial aspect of the right ankle and top of the right foot; few small pink-red superficial abrasions ranging in size from 1/16 to ¼-inch involve the top of the right foot and top of the right second toe.
- Irregular dark purple bruise measuring 4 x 1½ inches involving the medial aspect of the left ankle.
- Multiple faint red-purple bruises ranging in size from ½ to ¾-inch involving the top of the left foot and lateral left ankle.

RADIOLOGY: No postmortem radiographs were taken.

INTERNAL EXAMINATION:**HEAD:**

Reflection of the scalp reveals no evidence of deep scalp or subgaleal hemorrhage. The calvarium is intact and unfractured. Removal of the calvarium shows the dura mater and falx cerebri to be intact. No collections of epidural or subdural blood are present. The brain weighs 1452 grams. The leptomeninges are thin and transparent with no evidence of subarachnoid hemorrhage or fibropurulent exudate. The cerebral hemispheres are symmetric and normally formed. There is no evidence of significant edema, atrophy or destructive lesions. There is no evidence of uncal or cerebellar tonsillar herniation. The vessels of the Circle of Willis have a normal distribution with no significant atherosclerosis, tears or aneurysms. The cranial nerves are intact. The cerebellum and brainstem are normally formed. Sectioning reveals the cortical ribbon to be intact and there are no focal lesions in the cortex, subcortical white matter, or deep gray matter of either hemisphere. The lateral and third ventricles are of normal size. Sectioning the cerebellum and brainstem shows no focal lesions. The first portion of the spinal cord viewed through the foramen magnum is unremarkable. The atlanto-occipital junction is intact upon palpation.

NECK:

Anterior neck dissection reveals no strap muscle or soft tissue hemorrhage and there are no injuries to the large vessels. The hyoid bone, thyroid cartilage and cricoid cartilage are intact and unfractured. The epiglottis is pink and not swollen. The larynx and trachea are lined with tan mucosa and unobstructed. The tongue is normal externally and on cut sections.

BODY CAVITIES:

The standard Y-shaped incision is made to reveal the thoracic and abdominal organs are in their normal anatomical positions. No adhesions or abnormal collections of fluid are present in the pericardial, pleural or peritoneal cavities.

CARDIOVASCULAR SYSTEM:

The heart weighs 372 grams. The epicardium is smooth with a minimal amount of epicardial fat. The coronary arteries arise normally, follow their usual distribution and are widely patent and free of significant atherosclerosis or thrombi. The chambers of the heart show the usual size and position relationships. The atrial and ventricular septa are intact. The foramen ovale is closed. The myocardium is red-brown and firm and has no focal or regional softening, erythema or fibrosis. The endocardium is smooth and brown and the cardiac valves are normally formed without vegetations. The aorta and its major branches arise normally and follow the usual course. The major aortic vascular branches are patent. The aorta has no significant atherosclerosis, tears or aneurysms. The vena cava and its major tributaries return to the heart in the usual distribution and are unremarkable.

RESPIRATORY SYSTEM:

The right lung weighs 1024 grams and the left lung weighs 1006 grams. The lungs demonstrate a normal lobation pattern. The pleural surfaces are smooth and have no adhesions. The upper airways are unobstructed and free of foreign material, purulence, excess mucus, hemorrhage or masses. The pulmonary arteries course normally and are free of thromboemboli. Sectioning reveals a pink (anterior) to dark red (posterior) parenchyma with diffuse vascular congestion and prominent lividity in the posterior dependent portions of the lungs. No focal mass lesions are identified.

GASTROINTESTINAL SYSTEM:

The esophagus is lined by unremarkable appearing, gray-white, smooth mucosa. The gastric mucosa is arranged in the usual rugal folds with multiple small dark brown ovoid lesions ranging in size from 0.1 to 0.2 cm in greatest dimension. The lumen contains 50 cc of dark brown fluid. No tablets or capsules are identified within the stomach contents. External examination of the small and large bowel reveals no adhesions, diverticula, masses or injuries. The appendix is present.

PANCREAS:

The pancreas has a soft, tan, lobulated parenchyma and is free of calcifications, cysts, hemorrhage or masses.

HEPATOBIILIARY SYSTEM:

The liver weighs 1248 grams and is covered by a smooth capsule. Sectioning reveals a red-brown parenchyma free of focal lesions. The gallbladder has a velvety green serosal surface and is opened to reveal dark green bile with no gallstones.

URINARY SYSTEM:

The right kidney weighs 116 grams and the left kidney weighs 128 grams. The renal capsules are smooth, thin and strip with ease from the underlying smooth cortical surfaces. Sectioning reveals the cortices are of normal thickness with good corticomedullary delineation. The calyces, pelves and ureters are non-dilated.

The urinary bladder contains 5 cc of clear yellow urine. The bladder mucosa is tan and unremarkable.

REPRODUCTIVE SYSTEM:

The prostate and testes are unremarkable.

ENDOCRINE SYSTEM:

The pituitary is unremarkable and of normal size.

The thyroid gland is normally formed and sectioning reveals soft, tan-maroon parenchyma without nodules or cysts.

The adrenal glands are normally formed and sectioning reveals no focal lesions.

RETICULOENDOTHELIAL SYSTEM:

The spleen weighs 110 grams. The splenic capsule is blue-gray, smooth and intact. Sectioning reveals deep maroon parenchyma without focal abnormalities.

No enlarged regional lymph nodes are noted.

MUSCULOSKELETAL SYSTEM: See "Medical Intervention" section.

MICROSCOPIC EXAMINATION

CASSETTE INDEX:

- A: Left ventricle of heart, lower lobe of right lung, spleen
- B: Septum of heart, lower lobe left lung, adrenal gland
- C: Right ventricle of heart, liver, pancreas, thyroid
- D: Hippocampus, cerebellum, kidney

MICROSCOPIC DESCRIPTION:

BRAIN: Hippocampus and cerebellum reveal no significant pathological changes.

HEART: Multiple sections of myocardium with variably sized myocytes and no overt acute necrosis, inflammatory infiltrates, hemorrhage or significant fibrosis. The right ventricle shows patchy fatty infiltration of the myocardium.

LUNG: Vascular congestion with patchy alveolar hemorrhage; no overt acute bronchopneumonia, granulomas or interstitial disease identified.

LIVER: Sinusoidal congestion; no significant pathological changes.

PANCREAS: No significant pathological changes.

KIDNEY: Tubular autolysis; no significant pathological changes.

ADRENAL: No significant pathological changes.

THYROID: No significant pathological changes.

SPLEEN: No significant pathological changes.

On December 14th, 2018, I was assigned to a Tri-County investigation with Detective Mike Marvin of Bingham County, Idaho. We were notified of an in custody death at Bannock County Jail. The death happened earlier this day. Detective Marvin arrived at Bannock County Jail and started the investigation. When I arrived, I talked with the jail Deputies that were involved with the care of the inmate, Lance A Quick, who died. I talked with them one on one.

Deputy Billings talked with me about making her rounds by walking around jail cells and looking in on the inmates. She was doing the 15 minute check on Mr. Quick. Deputy Billings had made this check several times before. Deputy Billings had offered food and drink to Mr. Quick earlier. He had refused and not taken either. The last time that Deputy Billings knew of Mr. Quick eating or drinking was sometime yesterday. When asked about her observations of Mr. Quick, Deputy Billings said Mr. Quick had done a lot of masturbation during his time at the jail. Mr. Quick seemed like his mind was in a different place. Deputy Billings thought that he may have been high on drugs or mental.

During her previous 15 minute checks, Deputy Billings explained when she found Mr. Quick laying on the floor, she would watch for Mr. Quick to breathe if he didn't answer her. She had seen in previous checks Mr. Quick breathing. She described the previous checks as Mr. Quick laying down on his back breathing with his stomach moving up and down as he inhaled and exhaled. Other checks Mr. Quick was walking around. When he was walking around she saw new bruising that she had not seen before and this had concerned. The bruising had not been there the day before.

Deputy Billings explained at about 1021 this morning, she was doing a 15 minute check on Mr. Quick. She looked into the cell and saw Mr. Quick laying on his back. She watched for him to breathe but didn't see his stomach move. Deputy Billings called out to Deputy Jackson to look at Mr. Quick and go into the cell together. Deputy Jackson came over and looked. Deputy Jackson and Sgt Shelton went into the cell and checked on Mr. Quick. There was a lot of people that came while she continued to do her jail cell checks and working in the booking area.

The next interview was with Sgt. Michael Shelton. He had been in the booking area working on hygiene of the inmates. He heard "Code Mike." Code Mike is requesting medical for a medical attention. He saw Deputy Jackson go to cell #8. He and Deputy Jackson went into the cell. He saw Mr. Quick's eyes were open and thought he was breathing. He checked for a pulse and breathing. He could not find a pulse or breath. Deputy Jackson called medical. He started CPR on Mr. Quick.

Then medical arrived. The nurse used the defibrillator on Mr. Quick. Deputy Shaffer continued CPR. The EMT and ambulance was in route. He went to the sally port and made it ready for the ambulance to arrive. When the ambulance arrived, he showed the crew which cell they were needed at. He saw an EMT go into the cell. There were too many people around and he backed out of the way. The EMT's loaded Mr. Quick into the ambulance and took him to the hospital. When all was finished, he stepped back behind the booking computer and went back to work.

Sgt Shelton talked about the little known history of Mr. Quick since he has been at the jail. Mr. Quick had been in cell #7. Because of Mr. Quick's behavior, he was moved to cell #8. At the time when he went into Mr. Quick's cell for the medical call, he saw Mr. Quick had clothing but he wasn't wearing any. Mr. Quick was covered with a blanket from his lower 1/2 down. Mr. Quick's jumpsuit was on the floor by Mr. Quick. Mr. Quick was laying on his back on the floor with the other part of his body on the mattress. Sgt Shelton had described cell #8 as a one man cell with nothing in it. There is no bed and no toilet. There is a drain in the floor. The mattress was covering the drain.

I had not seen Mr. Quick and I asked him to describe him to me. Sgt Shelton said before today, Mr. Quick looked extremely gaunt. He was very skinny. He may have been self-medicating with an unknown drug.

Deputy Jared Shaffer talked with me after Sgt Shelton. He said he was the transport officer for the day. He had just gotten back from court and saw a lot of people in cell #8. He looked in and saw that CPR was in progress. He locked down the inmate that he had brought back from court. He then came back into the booking area and offered to go with the ambulance unit to the hospital. He went with Mr. Quick and the ambulance to the E.R. room at Portneuf Medical Center. He held the IV bag while the EMT's continued CPR. When they arrived at the hospital, the hospital staff took over CPR. Deputy Shaffer remembers Mr. Quick being hooked up to a lot of pads. Mr. Quick was shocked several more times in an effort to bring Mr. Quick back. When they arrived at the ER, they were placed into room 17. Dr Jordan Marshal and the nurses continued to work on reviving Mr. Quick. At 1123. Dr Marshal called the time of death for Mr. Quick. Deputy Shaffer stayed in the room until Mr. Quick's body was tagged with his name and transported to the morgue. While waiting to be relieved, the parents said that their son needed his medication for his manic condition. They thought if he had been on his medication that the death could have been prevented, they were angry because of the situation.

The last Deputy to be interviewed was Deputy Jennifer Jackson/Warner. Deputy Jackson is senior on staff. She was doing booking with Deputy Billings. Earlier this morning, the Sheriff and the Designated Examiner had come in to the jail to work on getting Mr. Quick committed to mental health. The Designated Examiner had come in to talk with Mr. Quick. Mr. Quick did not talk. There was a committal hearing for Mr. Quick with the judge. Mr. Quick was there for the hearing but wouldn't say anything. Judge Murray was here at the Jail and had the paperwork done for Mr. Quick. That paperwork was handed to Deputy Hughes.

Mr. Quick was in close custody watch. He was not giving any response when meals and drink were offered. He also would not recognize the jailers when they were there. The Deputies had kept food and drink outside the cell if he ever wanted it. Deputy Jackson said earlier in the day she saw him breathing and laying on his side. She heard Deputy Billings tap on the cell door and ask if he wanted a drink. Deputy Billings then said to her, "Jackson, I don't think he's breathing." She came over to check. When she looked in on Mr. Quick, he was half naked, laying on his back with a blanket on his waist. She watched for breathing and counted to 5. She saw no breath with his stomach. She called out "Code Mike." The nurse came A.S.A.P. Sgt. Shelton came out and she popped the door. She and Deputy Shelton went in the cell. Deputy Jackson shook Mr. Quick and asked if he was ok. There was no response. She told Sgt. Shelton to do CPR. He started CPR while she went to the bathroom and got the breathing mask. She went back in and put it on Mr. Quick. She worked the breathing mask while Sgt. Shelton did CPR. She was very worried about Mr. Quick. Nurse Allison arrived and put the oxygen mask on Mr. Quick. She opened the AED bag and gave it to Nurse Allison. Nurse Allison applied the AED. It analyzed and said no shock. Deputy Shaffer came in and switched out Sgt. Shelton to do CPR. Nurse Allison checked for a pulse but could not find it. The AED still said no shock advised. Another AED was sought after. Nurse Allison was concerned that the current AED was a training unit and not a real AED. By the time the other 2 AEDs arrived, the nurse confirmed that the current AED was not a trainer but a real AED. The other 2 AEDs had come from medical and administration. She saw Mr. Quick take short shallow breathes. Then the EMTs took over CPR. They removed Mr. Quick out of cell #8 and in the hall, Deputy Jackson believes that Mr. Quick received Narcan and Epi. An IV was drilled into his shin, intubated, and then loaded into the ambulance. She cleared after Deputy Shaffer went with Mr. Quick and the ambulance.

On December 17th, Detective Marvin, Bingham County Coroner Mike Gardner, and I went to the Ada County Coroner's Office for the medical autopsy of Mr. Quick. After the autopsy was concluded, I took possession of the few items that
