COUNT 1: FIRST DEGREE MURDER, A
CLASS 1 FELONY Dangerous (Davonte
Marshone-Antonio Neal)

COUNT 2: DRIVE BY SHOOTING, A CLASS
2 FELONY Dangerous (Davonte
Marshone-Antonio Neal)

COUNT 3: DISCHARGE OF A FIREARM AT
A STRUCTURE, A CLASS 3 FELONY
Dangerous (Davonte Marshone-Antonio
Neal)

The Grand Jurors of Maricopa County, Arizona, accuse DAVONTE MARSHONE-
ANTONIO NEAL, on May 16, 2022, charging that in Maricopa County, Arizona:

COUNT 1:

DAVONTE MARSHONE-ANTONIO NEAL, on or about November 11, 2017, intending or knowing that his conduct would cause death, with premeditation did cause the death of Bryan T Burns, in violation of A.R.S. §§ 13-1101, 13-1105, 13-751, 13-752, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a firearm, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.

AND / OR IN THE ALTERNATIVE

DAVONTE MARSHONE-ANTONIO NEAL, on or about November 11, 2017, acting either alone or with one or more other persons, committed or attempted to commit Drive By Shooting, A.R.S. §13-1209, and in the course of and in furtherance of such offense, or immediate flight from such offense, DAVONTE MARSHONE-ANTONIO NEAL or another person caused the death of Bryan T Burns, in violation of A.R.S. §§ 13-1101, 13-1105, 13-701, 13-702, 13-751, 13-752 and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a firearm, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.

COUNT 2:

DAVONTE MARSHONE-ANTONIO NEAL, on or about November 11, 2017, intentionally did discharge a firearm, a weapon, from a motor vehicle at a person, another occupied motor vehicle, or an occupied structure, in violation of A.R.S. §§ 13-1209, 13-3105, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a firearm, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.

COUNT 3:

DAVONTE MARSHONE-ANTONIO NEAL, on or about November 11, 2017, knowingly did discharge a firearm at a non-residential structure, located at Elliott Road and Interstate 10 Overpass, in violation of A.R.S. §§ 13-1211, 13-3105, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a firearm, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.
